

Ms. Faulk advised that there have been three new admissions for February, and there are currently 27 female residents and eight male residents.

Sonja Trbovich, Transit Director appeared before the Board to introduce Jill Cunningham, Mobility Manager for Carroll County. Ms. Cunningham advised that she is the Mobility Manager for Tuscarawas, Carroll, and Harrison counties. Ms. Cunningham advised that she helps communities make connections with transportation providers. Ms. Cunningham advised that she works with Ohio Mid-Eastern Governments Association (OMEGA), who does the regional coordinated plan. Ms. Cunningham advised that her job is to network, meet with stakeholders, look for improvements in the program, and find and help fill the gaps in service. Commissioner Wirkner asked Ms. Cunningham who she is employed by. Ms. Cunningham advised that she is employed by the Tuscarawas County Senior Center, and the Mobility Program is an Ohio Department of Transportation (ODOT) 5310 Program, which is an 80/20 program. Currently, Tuscarawas County provides the matching funds, but they will be asking ODOT to cover more of the match because Ms. Cunningham covers more counties.

Tom Cottis, Emergency Management Agency (EMA) Director appeared before the Board to provide an update on the approaching storm. Mr. Cottis advised that, once again, Carroll County appears to be in the band that will produce ice from approximately 7:00 p.m. to 11:00 p.m. tonight. Mr. Cottis advised that after the ice, the precipitation could turn to snow or rain, but difficult to predict at this point. Tonight's storm is coming in like the last storm, but won't have as much ice. Mr. Cottis predicts .06 to .2 inch of ice is

likely. Commissioner Modranski asked when the ice will switch to rain or snow. Mr. Cottis advised that it will be after 11:00 p.m. tonight and will be a mess in the morning, either way. Mr. Cottis advised that the positive thing is, Ohio Department of Transportation (ODOT) can pretreat the roads this time because it will be snow flurries changing to ice, whereas last time, it rained first, so the pretreatment could not be applied.

IN THE MATTER OF **EMERGENCY MANAGEMENT AGENCY** WEATHER UPDATE



9:15 AM

Tom Cottis, Emergency Management Agency (EMA) Director appeared before the Board to provide an update on the storm that began last Thursday, February 17, 2022. Mr. Cottis advised that there was a lot of snow ripe which turned into run-off. National Weather Service (NWS) has estimated that the melting snow ripe turned in to 2-1/2 inches of run-off. Mr. Cottis advised that the high temperatures, combined with the rain and the rapid run-off equaled to over 4 inches of water going into the waterways. The water north of Carrollton went to Sandy Creek which had a lot of water. Mr. Cottis advised that residents near Lake Mohawk were calling to complain about Lake Mohawk releasing the water. Mr. Cottis advised that Lake Mohawk did not release water, and as of yesterday, Lake Mohawk is still up 13 inches, which is approximately 165 million gallons of water. Mr. Cottis advised that if Lake Mohawk had let the water go, it would have gone over the emergency overflow, and that did not happen. Mr. Cottis advised that Carroll County is nowhere near being able to do a declaration for damages. One of the differences between this event, and the previous flooding events is, 28 mobile homes in the Brown Township area are gone due to the mitigation buy-out programs, several homes have burned, and several are vacant. The remaining homes received funds in 2003, 2004, and 2008 and they will not be eligible to receive any more funds. This makes it hard to get a declaration when 20 destroyed homes is what the Federal Emergency Management Agency (FEMA) requires. Mr. Cottis advised that water has to be in the living area of the home, not just the basement, to qualify. Mr. Cottis advised that there is not enough damage on the private side. Numbers have been run for the public side, and they are not enough, either. Harrison County was able to file a declaration. If Harrison County's declaration gets approved, there is a possibility that Loudon and Perry townships could be included for their road damages. Mr. Cottis discussed damages in the previous events that helped Carroll County reach the dollar amount needed to get a declaration. Mr. Cottis advised that he had Devin Herrington, EMA Deputy Director watch the Riverview Drive area in case residents need help getting out. The creek crested and then began to recede, and there were no issues. The Conotton Creek crested on Saturday. Mr. Cottis advised that the United States Army Corps of Engineers (USACE) has been doing a great job. State Route 212 is still open as of this morning. The local reservoirs are up over summer pool right now. The USACE has been careful to release water in stages so that towns downstream remain safe. Commissioner Modranski asked if the pool levels will be brought back down, if conditions allow. Mr. Cottis advised that Leesville has to go down below the pool level due to the sewer project that will be starting. It will be a gradual process. Commissioner Wirkner advised that he wanted to clarify a few things about the county requesting assistance. Homes cannot just be surrounded by water, there has to be water in the living area of the home. Mr. Cottis advised that residents of a home on Azalea Road, just over the railroad tracks, advised that they would leave their home that night and ended up calling the next morning to request help getting out. Mr. Cottis advised that responders were able to get the family out safely. The family tried to get assistance, but there was no water in the living area and they still had power, so they do not qualify. Mr. Cottis advised that the family will be meeting with the Red Cross. Mr. Cottis advised that two percent of the population has to be affected to receive assistance. Mr. Cottis advised that the flood levels from 2003 and 2004 were high, and Carroll County is nowhere near those levels now.

IN THE MATTER OF **BOARD OF ELECTION MAY 2022 PRIMARIES**



9:30 AM

Commissioner Modranski advised that a legislative alert was received from the County Commissioners Association of Ohio (CCAO) with an update on the May 3rd Primary Election. Commissioner Modranski shared the following information from the alert: "As of this morning, Ohio has not established new state legislative and congressional district lines. Previously redistricting plans have been overturned by the Ohio Supreme Court multiple times and are subject to ongoing litigation. The Ohio Redistricting Commission will meet today and tomorrow in an effort to produce maps that are constitutionally compliant, although the eventual outcome of these efforts is unknown. Regardless of the product of those discuss, it appears that the May 3rd primary election is in significant jeopardy. [Tuesday], Ohio Secretary of State Frank LaRose issued a directive to county boards of elections, directing them to prepare for a May 3rd primary that did not include state legislative and congressional contests. In a separate letter to legislative leaders outlining the numerous logistical challenges of May 3rd primary election, LaRose emphasized: 'Let me be clear on this point: it is impossible to see a scenario in which these maps are favorably passed by the Redistricting Commission, challenged by litigants, reviewed by a court, and given final approval within a timeframe conductive to a May 3, 2022, primary election date.' Ohio Attorney General Dave Yost yesterday also issued a letter to state lawmakers, outlining the General Assembly's legal options for conducting the primary election. One idea would be to move the entire primary election to a later date. Another alternative would be to bifurcate the primary, holding state legislative and congressional primary contests later in the year after redistricting disputes have been resolved while allowing all other contests to take place on May 3rd." Commissioner Modranski advised that if two primary elections have to be held, it will be a significant burden to the county. The estimate is \$50,000 to \$100,000, or more, for Carroll County to hold a second election. Commissioner Modranski advised that CCAO has sent a letter to the state requesting that the state pay for the cost of a second election, if needed. Commissioner Modranski advised that he had a meeting with the Board of Elections to discuss different options. Commissioner Wirkner advised that he saw an estimate for Carroll County to have a bifurcated primary could be as much as \$109,000. Commissioner Modranski advised that the cost is not the only concern. Poll workers and voter confusion are issues of concern, as well.
