Mr. Nichols advised that there is legislation in place for counties and government entities to work with companies such as ABM who will work to find ways to lower energy and repair bills to offset the cost of other improvements. Commissioner Wirkner asked how in depth the company's request for information will be. Mr. Nichols advised that they would need utility information, square footage of the facility, and a walk through to start with. Sergeant Samantha Shafer, 911 coordinator appeared before the Board to introduce the Text to 911 service that will soon become available to Carroll County residents. Ms. Shafer advised that testing of the service starts tomorrow for Carroll County. Ms. Shafer advised that it would be appropriate to use texting to reach 911 if someone has a communication barrier where calling would be more difficult (deaf, hard of hearing, physically unable to speak), if cell signal is too low but texts may still go through, situations where speaking or making noise would put your safety at risk, or if someone is having a medical emergency which prevents them from being able to speak. Anyone within Carroll County can use the service if they have texting available on the device and their cellular provider has enabled the service to their customers in Carroll County. Ms. Shafer has been in contact with Verizon, Sprint, T-Mobile and AT&T. The system is designed to send a default message advising you if Text to 911 is not available when attempting to use the service. This is set up by the phone providers. Ms. Shafer advised that while it is helpful, it is not the most reliable or efficient way to communicate with 911 and that you can experience delays or texts can be received out of order. Texting may not be available if the phone is roaming. 911 texts cannot be translated into other languages. Ms. Shafer advised that for emergencies where that is an issue, the caller will need to dial 911 for the dispatcher to begin locating them and contacting an interpreter. Ms. Shafer advised that to use Text to 911, you enter 911 in the "to" field of your text message, enter brief details of your situation, and push send. Answer the dispatcher's questions. Ms. Shafer offers other helpful tips such as to be direct, give only pertinent information, provide your location, keep it simple, avoid abbreviations, slang, and excessive details. 911 can only accept Short Message Service (SMS) messages at this time, no video, pictures, or emojis. Ms. Shafer advised that you cannot send a group text to 911, it only supports a conversation between one person and the dispatch center. When texting 911 in an evolving situation where your safety is a concern, make sure your phone is in silent mode, with all alert and notification sound disabled. Sometimes texts get delayed and are not received when sent, this can happen when texting 911. Texting should be a secondary option only since calling can provide better details quicker. Ms. Shafer advised to never text and drive. There will be a fact sheet regarding the service on the Sheriff's website. Commissioner Wirkner advised that this service has been 10 years in the making. Ten years ago, Carroll, Columbiana, and Morgan counties came together to move their counties to Next Generation 911 and those counties decided to share the cost of the equipment and infrastructure expenses. Commissioner Wirkner advised that during that time, they realized that they needed Text to 911 implemented not only for those who cannot talk, but for the younger generation who prefers texting over talking. Commissioner Modranski asked if a person can text 911 from a deactivated phone. Ms. Shafer advised that as of right now it would work but there was information sent out that deactivated phones will soon no longer be able to access 911. Mr. Modranski asked if you are on the County line between Carroll and Tuscarawas County, will the text service work. Ms. Shafer advised that it would depend on which county the text was routed through. If that county does not offer the service, the individual will receive a message that tells them that the service is not supported.
