Ed Eick, Maintenance Supervisor appeared before the Board to advise that he obtained three quotes to recoat the floor on the first level of the Courthouse. Mr. Eick is looking for a more permanent solution for the floor instead of repainting it every couple of years. Mr. Eick received three quotes. The three quotes include Superior Floor Coatings in the amount of \$4,950.00, Elite Floor Coatings LLC in the amount of \$5,995.00, and DuraFloor Epoxy Pros in the amount of \$7,714.00. Mr. Eick met with all the companies and all three of them would use a similar process. Mr. Eick recommends that the Board accept the quote from Superior Floor Coatings in the amount of \$4,950.00 to have the floor grinded, repaired, and coated. Commissioner Wirkner asked Mr. Eick how much it cost in the past to paint the floor. Mr. Eick advised that in the past he was able to have the help of two jail inmates to prepare the floor for painting but that is no longer an option. Mr. Eick estimates that hiring people to help prepare the floor and painting it will cost roughly \$1,500.00 and it usually need repainted every two years, whereas having it coated will last 15 to 20 years. Commissioner Wirkner asked what the surface of the floor will look like. Mr. Eick advised that he is going to have it recoated in tan to match the cabinets and he provided a pamphlet for the Commissioners to look at. Commissioner Modranski asked if there would be any rise in the coating or concern for a trip hazard. Mr. Eick advised that the floor will be completely smooth. Mr. Eick advised that if the project is approved, he would like to schedule the work to be done the week before Memorial Day to give the floor extra time to dry over the three-day holiday weekend. Commissioner Modranski asked what the dry time is for the project. Mr. Eick advised that the company told him it would only take 24 hours to dry but he personally would like to give it more time to cure.
