Ms. Offenberger advised that yes, they try to place children with relatives whenever possible but there are currently 20 children in the custody of Job and Family Services. Commissioner Modranski asked if individuals interested in fostering can call Job and Family Services and Ms. Offenberger said yes and she advised that Job and Family Services is coordinating with the Corporation for Ohio Appalachian Development (COAD) to recruit homes for foster care, especially for adolescents.
