

There are currently 50 plus employers who are hiring. Ms. Burns advised that there are employment applications at their office, and they will submit those to the appropriate business. In April, there

were two company-specific hiring events, PCC Airfoils and HWI. Around 30 job seekers attended those events. The next event will take place at a health care facility and will be looking for home health care aides. Ms. Burns advised that there will be virtual job fairs offered through the Work Force Area. Anyone can sign up for those, both employees and employers. Ms. Burns advised that they are actively seeking youth for the Summer Youth Program. There are multiple employers who are looking for summer youth help. Ms. Burns advised that there are training programs for adults who may have been laid off and are interested in high demand jobs. JFS can help pay for training such as CDL, nursing, heavy equipment or dental hygienist. There is also the Incumbent Worker Training program that provides training for current employees who need to get a certification for a promotion. The employer must be in Carroll County to participate in this program. Ms. Burns advised that tax credits are available for companies who hire within a specific target group. Ms. Burns provided details about services offered through the Prevention Retention and Contingency (PRC) program. The PRC program can help new workers with auto related expenses such as repairs, obtaining licenses, or gas vouchers. The PRC program can also help with purchasing uniforms or tools. There is driver's education assistance to help those who are 15.5 years and older. Commissioner Wirkner stated that he is astonished at how the paradigm has changed. Commissioner Wirkner stated that when he became commissioner the narrative was to create jobs. Now, the narrative is how to find people to fill the vacant jobs. Commissioner Wirkner stated he is amazed at the number of services that is offered by Ohio Means Jobs. Kate Offenberger, Job and Family Services Direct stated that there is a problem finding individuals who are motivated to work. The driver's education program was started last year and have helped 13 individuals, seven last year and six this year. Ms. Offenberger stated that the problem was participants had to go to either New Philadelphia or Canton for the class. Commissioner Wirkner asked if someone is looking to find a job, what are the steps that they need to take. Ms. Burns answered they can come into the Ohio Means Jobs office, and there are computers available. Staff is also available to help them search for jobs and can help them print resumes. Commissioner Wirkner asked where the Ohio Means Jobs office is located. Ms. Burns answered 55 E Main Street. The entrance is off of the alley behind the library.

Commissioner Wirkner provided an update on the recent 911 Technical Services Advisory Committee (TAC) and 911 Planning Committee meetings. Commissioner Wirkner advised the Emergency Services Internet Protocol Network (ESINnet) has established standards for 911 dispatchers. It was discovered that there are a few standards are not met. Commissioner Wirkner advised that the TAC made a recommendation to authorize each dispatcher to receive up to \$500 in training at nationally recognized facilities. That training will include crisis and fire response training. In the past, the training was provided in house. The TAC agreed that the training should be done with a nationally certified instructor. Commissioner Wirkner advised that he met with Samantha Shafer, 911 Coordinator. Commissioner Wirkner advised that it was agreed that two dispatchers will attend the training and then take the material they learned and train the rest of dispatch. The TAC approved the recommendation followed by the Planning Committee. The recommendation needs the Board's approval. Commissioner Modranski asked if those who take training by the certified instructor will be certified instructors themselves. Commissioner Wirkner answered yes, once the two dispatchers take the training, they will be certified instructors.

Commissioner Wirkner met with the app creator who also manages the county Wireless Emergency Notification System (WENS). The app can be customized by the user to show the information they want to see such as the current weather, forecast or various alerts. These changes can be made any time. Commissioner Wirkner advised that the next step is to get the app certified by the various app stores. Commissioner Wirkner advised that getting the app operational is the next step towards getting storm ready certified. Once the county is storm ready certified, the county is eligible for grants.
