The program funding will benefit Appalachian communities for transformational local projects with three priorities: Infrastructure, including downtown development; Health care, such as investments in school- or community-based services to address physical and behavioral health; and Workforce development, including public-private partnerships to build and coordinate job training. Commissioner Modranski stated that this program will not be for traditional infrastructure such as roads, water and sewer, or broadband. The Ohio Department of Development is currently working on guidelines which should be available by the end of July. It is encouraged for counties to work with their Local Development District (LDD). For Carroll County, that is Ohio Mid-Eastern Governments Association (OMEGA). Commissioner Modranski advised that the bill signing took place in the Appalachian Garden, and he received a pen that the Governor used to sign the bill. Commissioner Wirkner asked how many counties are in the Appalachian Region. Commissioner Modranski answered 32. Commissioner Wirkner asked if the grant will be competitive. Commissioner Modranski answered yes, the biggest way to earn points is collaboration with other communities, counties, or action groups. Commissioner Modranski advised ideas that were tossed out include bike paths that connect two municipalities. Commissioner Ohler asked what are the earmarks that are eligible for the grant. Commissioner Modranski answered there are 3 tiers: Infrastructure which includes downtown revitalization; Healthcare which included mental, behavioral and physical health; and Workforce development.
