The <u>Board of Commissioners</u> of <u>Carroll</u> County, Ohio, met in <u>regular</u> session on the <u>21<sup>st</sup></u> day of <u>July</u>, 20<u>22</u>, at the office of the <u>Board of</u> <u>Commissioners of Carroll County, Ohio</u>, with the following members present: <u>Christopher R. Modranski, Jeffrey L. Ohler and Robert</u> <u>Wirkner</u>.

Mr. <u>Ohler</u> moved the adoption of the following Resolution:

BE IT RESOLVED by the Board of Commissioners of Carroll County, Ohio, that:

**Section 1.** This Board determines and declares that the amount of taxes which may be raised within the ten mill limitation will be insufficient and that it is therefore necessary to levy a tax in excess of the ten-mill limitation for the benefit of <u>the entire territory</u> of <u>Carroll County</u>, <u>Ohio</u>, for the purpose of <u>maintenance and operation of school and preschool programs and buildings for eligible</u> children from ages three to twenty-two years of age who have mental retardation and developmental disabilities by the <u>Carroll County</u>. <u>Board of Developmental Disabilities (Carroll Hills Program) ORC 5705.19 (L)</u>, at a rate not exceeding <u>1</u> mill for each one dollar of valuation, which amounts to <u>ten (\$0.10) cents</u> for each one hundred dollars of valuation for <u>ten (10) years (2023, 2024, 2025, 2026, 2027, 2028, 2029, 2030, 2031, 2032</u>), and which levy is <u>a renewal of an existing levy of 1 mill</u>.

Section 2. The question of approving the levy shall be submitted to the electors of <u>the entire territory of Carroll County</u>, <u>Ohio</u> at the election to be held on the  $8^{th}$  day of <u>November</u>, 20<u>22</u>, and that said levy be placed on the tax lists of the current tax year, commencing in 20<u>23</u>, first due in calendar year 20<u>24</u>, in compliance with the provisions of ORC 5705.34, if a majority of the electors voting thereon vote in favor thereof.

Section 3. The Clerk of this Board is directed to certify immediately a copy of this resolution to the County Auditor of Carroll County requesting that the County Auditor certify to the Board the total current tax valuation of Carroll County and the dollar amount of revenue that would be generated annually by the  $\underline{1}$  mill levy.

**Section 4.** It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open in the public, in compliance with law.
