# **COUNTY JAIL WINDOWS PROJECT**



Ed Eick, Maintenance Supervisor appeared before the Board to provide an update on the County Jail Windows Project. Mr. Eick advised that one question that has come up during the planning phase of the project is whether the windows should be operable or fixed. The first thing to evaluate is the HVAC system, which has been updated and allows enough fresh air into the jail to meet the state standards. Mr. Eick spoke with the jail staff and Major Calvin Graham, and all agreed to use fixed windows. Mr. Eick advised that Scott Filicky with the Ohio Department Rehabilitation and Correction (ODRC) came to evaluate the windows. Mr. Eick advised that the windows are the original windows from when the jail was built and are not up to current ODRC standards. One standard that the windows do not meet is windows below six feet above the ground must be sealed. The current jail windows are only three and a half feet above the ground and can open. It was also discovered that there are also security concerns with the current operable windows. Another issue with operable windows is they can be opened while air conditioning or heating is running and can lose energy. Commissioner Ohler asked if there are any Ohio Revised Codes that pertains to jail windows. Mr. Eick answered there is fresh air mandate which the HVAC system meets. Commissioner Modranski asked if there is a cost difference. Mr. Eick answered that the fixed windows should be cheaper than operable windows.

Anyone wishing to become a volunteer can speak with Ms. Faulk for more information. Ms. Faulk provided a COVID procedure update. Visitors will have a temperature check, fill out a survey, and wear a mask. Residents are able to go out with families and participate in outings. It is advised to avoid crowded areas such as busy stores or restaurants. Ms. Faulk advised that the HVAC System Project is currently waiting for parts. The air handlers and duct work has been installed. Ms. Faulk advised CGAR is ending the month with 33 residents: 23 female, 10 male, and two new admissions.

## IN THE MATTER OF **JOB AND FAMILY SERVICES**



Kate Offenberger, Job and Family Services (JFS) Director appeared before the Board to provide an update on the Temporary Aid for Needy Families (TANF). Ms. Offenberger presented information on the Back-to-School TANF Clothing and School Supply Program. In the past, JFS would give \$200 vouchers to families to spend at Walmart. However, this program was stopped because Walmart would no longer take the paper vouchers. Ms. Offenberger advised that, typically, this voucher program would total around \$275,000. Because the voucher program is no longer used, there are TANF funds that weren't used plus additional \$110,000 TANF funds added this year. Ms. Offenberger advised that JFS ran reports and identified 536 households that receive either TANF or Supplemental Nutrition Assistant Program (SNAP) assistance and have minor children. These families will receive \$300 per child to pay for school clothes and school supplies. Ms. Offenberger advised that 1,161 children will be served with this program. The program will total around \$348,600. This will be all federal funding with no funding coming from the county. Commissioner Modranski asked if there are any regulations tied to this program. Ms. Offenberger advised that the checks will be written directly to the families. These funds are to be used for school supplies. Commissioner Ohler asked if receipts are to be turned in. Ms. Offenberger answered that was discussed, but it is not required. Ms. Offenberger advised that there was a state-wide discussion on spending TANF funds, and it was decided that without Walmart accepting the vouchers, this is the best method. Commissioner Modranski asked if the county does not spend the money, does it go back. Ms. Offenberger answered that if the county does not spend the TANF funds, the money will go back to the state who will then disburse the funds to other counties. Ms. Offenberger advised that she can also transfer unused funds to other counties. Commissioner Modranski stated that it is best to keep these funds in Carroll County.
