The Kinship Permanency Incentive Program provides periodic support for families for up to three years. Ms. Offenberger advised that the Public Children Service Association had their annual conference last week, and Lisa Bible was awarded the Family of the Year award. Ms. Offenberger read a letter from Jessica Flowers, a former case worker. Ms. Offenberger advised that Ms. Bible was a neighbor to a family that JFS was involved with.
