Commissioner Modranski advised that Carroll County suffered a heartbreaking loss Saturday morning with the passing of Sheriff Dale Williams. For the past 18 years, Sheriff Williams served the people of Carroll County selflessly, with dignity, honor, and pride. Commissioner Modranski advised that in 2006, Sheriff Williams took a chance and hired him to fill a vacancy in the dispatch center. Commissioner Modranski advised that if Sheriff Williams had not taken that chance and hired him, he may not be a commissioner today. Commissioner Modranski offered his condolences to Sheriff William's wife, Leona, and their family during this difficult time and thank them for their sacrifices over the last 18 years, allowing him to serve this great county. Commissioner Modranski advised that the courthouse bell tower will be lit up blue in Sheriff William's honor for the next 18 days, representing his 18 years of service. Commissioner Modranski advised that at this time, the commissioners must discuss an appointment to the position of sheriff as required Ohio Revised Code 305.02 (F). Sheriff Williams made it clear to the Board of Commissioners before his passing that his recommendation for his successor is Colonel Calvin Graham. Commissioner Modranski advised that Mr. Graham started his career with the Carroll County Sheriff's office in 1993 and was promoted to Sergeant by 1997. Mr. Graham currently holds the rank as Colonel and served as the Sheriff's second in command. Commissioner Modranski opened the floor for discussion for the appointment of Colonel Graham to the office of Carroll County Sheriff. Commissioner Wirkner advised that he would like to direct a few guestions to Colonel Graham. The first guestion asked was whether Colonel Graham met the mandated requirements to fulfill the office of Sheriff, and Colonel Graham answered yes. The second question asked by Commissioner Wirkner was whether Colonel Graham had the operational administrative experience to fulfill the duties of Sheriff; Colonel Graham answered yes. Commissioner Wirkner then asked Colonel Graham if he had the will to serve the people of Carroll County as Sheriff and Colonel Graham responded yes.
