### IN THE MATTER OF SENIOR CENTER UPDATES

### 赵 9:07 AM

Tonya Myers, Council on Aging Executive Director appeared before the Board to offer updates on the senior center. Ms. Myers advised that the senior center is delivering over 300 meals every day and frozen meals are delivered on Wednesdays and Thursdays. Ms. Myers advised that they are in the process of prepping for snow days. The Area Agency on Aging (AAA) has approved three snow days this year, so additional boxes will be sent out to all residents on their routes for those three days. Ms. Myers advised that if they exceed the three snow days, the AAA will approve those on an as needed basis. Ms. Myers advised that 40-60 people a day are utilizing the curbside window and 15 to 30 people are eating in house. Ms. Myers advised that staffing is a concern, and she has been discussing creative ways to get additional subs. Thankfully, the volunteer staff has been able to help in the kitchen and on delivery routes. Ms. Myers advised that Music for Meals is a blue grass fundraiser that is held the second and the fourth Tuesday of the month and there are 45-70 people that attend that. Ms. Myers advised that they open the café for these events and any money made, goes towards their Meals on Wheels fundraiser. Ms. Myers advised that the Senior Center will be getting certified in Bingocize and a walking class, and they will receive funding available from AAA. Ms. Myers advised that they are continuing to offer a Matter of Balance class which is a fall prevention class. Ms. Myers advised that the Welcome and Wellness Program is also going on and it has been very helpful with introducing seniors to the programs that are available to them. Ms. Myers advised that the Welcome and Wellness Program also runs the grocery and drug program that seniors 60 and older can call to have someone deliver groceries or their prescriptions to them from Drugmart or Sanders. Ms. Myers advised that a Health Department employee, Anne Halm will be working out of the Senior Center doing the Bridges to Wellness Program. Ms. Myers advised that Ms. Halm will be like a social worker, and she will be assisting seniors with getting their medications organized and helping them to plan their follow up doctor visits. Commissioner Wirkner asked if she will work from the Senior Center and Ms. Myers said yes. Ms. Myers advised that she is also seeking permission to remodel the kitchen at the Senior Center. Ms. Myers advised that the Health Department guidelines have changed, and the condition of the kitchen has declined. She would like to upgrade everything to stainless steel to make it more like a commercial kitchen. Ms. Myers advised that she has a rough draft plan which includes changing a few bathrooms on the kitchen side to a dish room and adding two additional packing and prepping areas. Ms. Myers advised that due to COVID and the increase in numbers of people working in the kitchen, it would be beneficial to add more room for people to spread out. Ms. Myers advised that the project is going to cost around \$70,000.00 and the project will have to be put out for bid. Ms. Myers advised that she has never put a project out for bid, and she would like to work with Commissioner Modranski on how to do this. Commissioner Wirkner asked if Tonya is seeking a motion to upgrade the kitchen and if she has the money to do the project. Ms. Myers advised that yes, she is seeking a motion to upgrade, and that she has CARES Act money combined with money from the Meals on Wheels fundraiser that she can use for this project.
