Commissioner Modranski gave the floor to Rodger Barto, American Legion Post #428 Post Commander, Jim Newbold, Veterans of Foreign Wars (VFW) Post #3301 Quartermaster, and Tom Barnett, Legion Post #428 Treasurer to discuss the Memorial Day Grant. Mr. Barto congratulated Commissioner Leggett on his election as commissioner. Mr. Barnett provided a Memorial Day Grant request to each commissioner and the media. Mr. Barnett advised that it is time to think about Memorial Day 2023 and the funds they will need. Mr. Barnett advised that the grant request to the Commissioners is in addition to the \$500.00 they receive every year from the Auditor's office. Mr. Barnett advised that Memorial Day was established after the Civil War to honor those who made the ultimate sacrifice to the United States of America. Mr. Barnett advised that American Legion Post #428 is honored and charged to help commemorate the service and sacrifices of all Carroll County veterans. Mr. Barnett advised that Jim Newbold, Quartermaster from the VFW Post #3301 is also in attendance. Mr. Barnett advised that the Legion Post #428 works with the VFW Post #3301. Mr. Barnett advised that last year, Legion Post #428 requested \$650.00 for Memorial Day 2022. Mr. Barnett advised that this year, Legion Post #428 is requesting grant funding in the amount of \$1,350.00. Mr. Barnett advised that this higher number represents a \$700.00 increase due to inflation and accelerated costs. Mr. Barnett advised that the total capital outlay needed to meet all obligations for Memorial Day 2023, should not exceed \$1,850.00. Mr. Barnett advised that the cost of grave flags has significantly increased. Mr. Barnett advised that the veterans' organizations and the boy scouts place these small flags on the graves of all veterans. Mr. Barnett asked Mr. Barto what the cost of the flags are and if they are over \$2.00 to \$3.00 apiece. Mr. Barto advised that they cost more than that, but he is not sure of the exact amount. Mr. Barnett asked Mr. Barto how many they use and he replied that they use 2,000 flags. Mr. Barnett advised that in 2021, Post #428 broke even on cost but in 2022 they suffered a cost deficit in the amount of \$364.62 and had to cover this shortfall "out-of-pocket." Mr. Barnett advised that Post #428 is different than VFW Post #3301 in that Post #428 is a 501C-19 non-profit corporation and does not have any positive cash flow business

opportunities or involved in any commercial enterprises. Mr. Barnett provided a summary of Post #428 financial activity for 2022. Mr. Barnett advised that Legion Post #428 works with about \$15,000.00 a year. Mr. Barnett advised that elected officials, attorneys, civic organizations, and local veterans donate money to their youth programs. That money is used for Buckeye Girls and Buckeye Boys State and A & G testing. Mr. Barnett advised that they do receive a small amount of money from each member's dues. Mr. Barnett advised that they do receive some private donations, and around Memorial Day, they sell poppies and make around \$1,300.00. Commissioner Wirkner asked Mr. Barnett to give an example of the youth projects. Mr. Barnett advised that they sponsor students from the high school to attend Buckeye Girls State and Buckeye Boys State, which is held on a college campus, and they set up a mock government so the students can learn about local, county, state, and federal government. Mr. Barnett advised that they also offer A & G tests. Mr. Barnett asked Mr. Barto to explain more about the A & G tests. Mr. Barto advised that the tests are given to students in their government class. There are 50 questions, and each question is worth two points. Mr. Barto advised that the top scoring students win \$50.00, and a dinner is given for them. Mr. Barto advised that this program really helps to increase students' knowledge of government. Mr. Barnett advised that they have about 100 members, and they are looking for two more members to make their quota. Mr. Barnett passed out a brochure regarding membership. Mr. Barnett advised that he has served on the Veteran Service Commission since 2016, and they meet once a month. Mr. Barnett advised that the Veteran Service Commission asks for \$500,000.00 every year from the commissioners and always gives back \$100,000.00 to the general fund. Mr. Barnett advised that the Veteran Service Commissions has 88 offices in Ohio, one in each county. Mr. Barnett advised that in last October, a State Representative from Athens proposed House Bill 729, which had no co-sponsors. Mr. Barnett stated that the bill would charge the Veteran Service Commission to eliminate Vietnam veterans, replace them with veterans whose military service commenced on or after September 11, 2001, and change the appointment process. Mr. Barnett stated that the bill would give the appointment responsibility to the County Commissioners. Mr. Barnett advised that in the last meeting, the Veteran Service Commission Officer, Cindy Black advised that any grant funding requested from the county is coming out of her budget. Mr. Barnett stated that he thought the money being requested is coming from the general fund. Commissioner Wirkner advised that in the past, any request for funding has come directly from the general fund. Commissioner Modranski agreed, stating yes, the money comes from the general fund. Commissioner Modranski advised that perhaps Ms. Black is suggesting that the money is coming from her budget because of the \$100,000.00 that is being given back to the general fund. Commissioner Wirkner stated that the commissioners' position has always been to spend whatever is necessary on our veterans, but don't waste it. Commissioner Modranski suggested that, in regards to the proposed House Bill 729, trying to remove Vietnam veterans from being recognized is the reason why there are no co-sponsors on the bill. Commissioner Modranski asked where they purchase their flags from. Mr. Barnett advised that they purchase them from American Legion Emblem Sales from Indianapolis, Indiana. Mr. Barto advised that they usually purchase the cotton flags. Commissioner Modranski asked which cemeteries do they take care of. Mr. Newbold answered Westview, Grandview, Mechanicstown, Harlem Springs, Kilgore, Glade Run, and Scroggsfield. Mr. Newbold advised that they picked up a few more, but he doesn't remember the name of them. Mr. Barto advised that the boy scouts and girl scouts help them put the flags out, and they take them to Pizza Hut to thank them. Mr. Newbold advised that Flags Across America has reached out to them to find out how many veterans are buried in Grandview and Westview cemeteries. Mr. Newbold advised that he has no idea. He tried to reach out to the sexton from the township, and they do not know either. Mr. Barto advised that he collects the flags from the courthouse collection box once a month. Mr. Newbold advised that there were 1,000 flags collected that were burned during their flag burning ceremony. Mr. Newbold advised that VFW Post #3301 is requesting \$1,389.36. Commissioner Leggett asked if they order more flags per order, do they get a better deal. Mr. Newbold answered no, he doesn't think that's the case. They just save on shipping. Mr. Barto advised that they buy flags in gross. Mr. Barto advised that last year, they ordered thirteen grosses. Mr. Newbold advised that the boys scouts and girl scouts help them place the flags which has saved them several hours. Mr. Barto advised that Mr. Newbold purchases them pizza from his own pocket to show his gratitude. Mr. Newbold advised that after they remove the flags from the graves, they hand them out to people who purchase poppies on poppy day. Commissioner Wirkner asked if the total request between Post #3301 and Post #428 is \$1,350.00, in addition to the \$500.00 from the Auditor. Mr. Newbold advised that the request for \$1,350.00 is for Legion Post 428 and VFW Post #3301 is requesting and additional \$1,389.36 from the general fund. Mr. Barto advised that they must pay for the sound system, music, and buglers for the Memorial Day event.

Motion: to approve a grant to Legion Post #428 in the amount of \$1,350.00 and a grant to VFW Post #3301 in the amount of \$1,389.36, **Action:** Vote was recorded as follows: YEA: President Christopher R. Modranski, Vice President Robert E. Wirkner, and Commissioner Donald E. Leggett II; NEY: None; ABSTAIN: None, **Moved by** Vice President Robert E. Wirkner, **Seconded by** Commissioner Donald E. Leggett II.

Motion carried on unanimous vote.



Commissioner Wirkner stated that it was a good thing to share with the community what is happening in each of these organizations. Mr. Barnett asked if the commissioners need a formal letter submitted. Commissioner Modranski advised that the grant requests would be ran through the Auditor's office, and the Commissioners' office will call them when the checks were ready.
