Commissioner Modranski turned the meeting over to Commissioner Wirkner for the Emergency Services Recognition Ceremony. Commissioner Wirkner thanked all County Emergency Services Personnel. Commissioner Wirkner advised that our Emergency Services Personnel are charged with saving lives and protecting property every day of the year, and they can never be adequately compensated or sufficiently recognized for the sacrifices made for our communities. Commissioner Wirkner advised that the Board of Commissioners have determined that they should express their appreciation for the sacrifices and dedication to duty of every one of the county's Emergency Services Personnel and recognize those individuals who have come to the attention of the Selection Committee. Commissioner Wirkner advised that the Selection Committee considers those that have demonstrated actions that have saved lives, demonstrated gallantry, or are worthy of commendation. Commissioner Wirkner advised that the Selection Committee continues to encourage emergency service leaders to nominate those that they feel qualify for an award. Commissioner Wirkner advised that the Selection Committee found that although some of those nominated do not meet the criteria for one of the three categories that was established, they may qualify for Honorable Recognition. Honorable Recognition is reserved for nominees who don't meet the criteria for the three main awards, but their actions are still worthy of recognition. Commissioner Wirkner advised that this year there was an Emergency Medical Dispatcher nominated for commendation. Commissioner Wirkner advised that the Commissioners are often asked why they fund multiple dispatchers in the dispatch center. Commissioner Wirkner advised that the Emergency Medical Dispatchers are able to stay on the line with the caller and guide them through assistance that is needed until emergency services arrive on the scene. Commissioner Wirkner advised that there were citizens involved in this case, deserving of a citizen's proclamation, but they wish to remain anonymous. Commissioner Wirkner advised that they do not want to relive the emergency, or they are humble and do not want to be awarded a proclamation. Commissioner Wirkner advised that there were individuals who helped in this situation, but they needed guidance to perform CPR for a person who required medical assistance. Commissioner Wirkner advised that Emergency Medical Dispatcher, Brittney Gifford, aided the individuals and provided the steps needed to help preserve life until the ambulance arrived. Commissioner Wirkner advised that the Commissioners would like to issue a certificate of Honorable Recognition to Ms. Gifford. Commissioner Wirkner asked Ms. Gifford to step forward. Ms. Gifford was given her certificate and pictures were taken. Commissioner Wirkner asked Ms. Gifford's supervisor, Samantha Jacobs, 9-1-1 Coordinator if she wished to say anything. Ms. Jacobs said that she and Sergeant Tullis reviewed the call and both feel that Ms. Gifford went above and beyond with this stressful call by keeping everyone calm and issuing CPR instructions. Commissioner Wirkner asked Sheriff Calvin Graham if he wanted to share any comments. Sheriff Graham advised that he appreciates all the dispatchers and the work they do to get the training needed and they are very dedicated to the job. Commissioner Wirkner advised that even though the family wants to remain anonymous, they wanted to express their appreciation for the work Ms. Gifford did on the call. Commissioner Wirkner advised that the individuals who were administering the CPR are also appreciative of Ms. Gifford's help. Commissioner Modranski advised that as a former dispatcher, he knows that oftentimes dispatchers only get to hear the complaints and don't often get to know the results of the call. Commissioner Modranski advised that he appreciates the work that Ms. Gifford did and is glad to see a dispatcher get recognized.
