## IN THE MATTER OF **PY21 & PY23 CHIP UPDATE**



Dale Hartle, Ohio Regional Development Corporation (ORDC) President and David Winner, appeared before the Board to give a PY2021 and PY2023 Community Housing Impact and Preservation (CHIP) Program update. Mr. Hartle advised that the PY2021 CHIP budget is \$425,100.00 and jobs through this grant are currently in progress with a work completion date of February 29, 2024. Mr. Hartle advised that they projected use of four units for owner rehab. Mr. Hartle advised that owner rehab is where they evaluate all the systems of the house and bring everything up to code. Mr. Hartle advised that if the money allocated to bring the house up to code is not enough, they have to walk away from it. Mr. Hartle advised that they can spend up to \$75,000.00 on a rehab house, which may sound like a lot, but building material cost has sky rocketed. Mr. Hartle advised that one rehab unit is in the rehab process, two are ready to be written up and the fourth will be written up by early summer. Mr. Hartle advised that the second part of the grant is for home repair which costs about \$15,000.00 to \$20,000.00 per project because they only need to fix one or two things in the home and not bring the entire house up to code. Mr. Hartle advised that it was projected that they would do seven units for home repair. Mr. Hartle advised that one house is already completed, five units are in progress, and they plan to do one or two more before the end of the grant in 2024. Mr. Hartle and Mr. Winner advised that the projects are going well, and people are pleased with the work being done on their homes. Mr. Hartle advised that is time to write an application for PY2023 CHIP. The applications are due June 21, 2023. Mr. Hartle advised that a Request for Proposal (RFP) for services will need to be done and that the ORDC would like to be chosen to write the grant for the county. Mr. Hartle advised that if ORDC is chosen, they will have two public hearings for the grant. Mr. Hartle advised that most of the communities that he works in would like to do many more home repairs where they address one or two issues instead of a whole house rehab, but the state only allows a certain percentage to go to home repairs. Mr. Hartle advised that home repairs are done with Community Development Block Grant (CDBG) dollars and rehabs are done with HOME Program dollars. Mr. Hartle advised that the state gets a lot more HOME Program dollars than CDBG dollars. Mr. Hartle asked if the county also received allocation money through the CDBG and Commissioner Modranski answered yes. Mr. Hartle advised that the state requires that each county does an Analysis of Impediments Study every five years. Mr. Hartle advised that the study needs to be done in 2024 and that Julie Kiser, Fair Housing Specialist from his office could write the study. He advised that it would cost \$6,000.00 and the cost comes directly out of the allocation program, not the general fund. Commissioner Modranski advised that Tom Konst runs the county's CDBG allocation program and partners with Sue from ORDC and is probably already aware of the study. Commissioner Modranski asked Mr. Hartle if the state is going to run the allocation program again. Mr. Hartle advised that a few years ago, he told all the counties to call their state representatives and tell them that they want this program to continue. Commissioner Modranski advised that they did call. Mr. Hartle advised that the allocation money does paving, culverts, water lines, and community parks. Mr. Hartle advised that through the CDBG funding, the county has been able to do several projects, such as a rail line to North Canton, a water sewage treatment plant for the Carroll Golden Age Retreat, air conditioning and furnaces in the courthouse. Mr. Hartle advised that so far, thanks to those that contacted their state representatives, the program continues. Commissioner Modranski advised that several municipalities used the funds to pave their streets before the state decided that the money could not be used for paving projects. Mr. Hartle and Commissioner Modranski both agreed that allocation is some of the greatest money the county receives. Commissioner Modranski advised that the allocation has an impact on more people community wide than CHIP does. Commissioner Modranski thanked Mr. Hartle and Mr. Winner for visiting Carroll County.

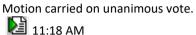
