IN THE MATTER OF **COMMUNITY HOUSING IMPACT AND PRESERVATION (CHIP)** COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) & FAIR HOUSING PUBLIC HEARING

Susan Moore, Community Development Specialist opened the public hearing for the PY23 Community Housing Impact & Preservation (CHIP) Program, the Community Development Block Grant Program (CDBG), and Fair Housing at 9:30 a.m. Ms. Moore advised that Carroll County is eligible to apply for up to \$400,000.00 through the CHIP Program. Ms. Moore advised that Owner Rehabilitation is capped at \$75,000.00 per project and can be for home ownership or rental. Rentals are eligible for assistance, but the landlord must contribute 50%. Owner Rehabilitation projects address multiple issues in a home. Commissioner Modranski asked Ms. Moore if the \$75,000.00 cap is per house, and she said yes. Commissioner Modranski asked if there is a minimum and she said no. Commissioner Wirkner asked if the cost to rehabilitate a house exceeds the capped amount, can the owner pay the overage. Ms. Moore advised that there is a point that is reached that if a house exceeds the capped amount, they will walk away from the house and not fix it. Ms. Moore advised that sometimes there is structural damage or foundation problems that cause them to walk away. Commissioner Leggett asked if the landlord's portion is included in the cap. Ms. Moore advised that she does not think so, but she will check on that and get back to Commissioner Leggett. Ms. Moore advised that Home Repair is capped at \$22,000.00. Home Repair projects focus on one significant problem with the home, such as roofing, furnace, or septic repair. Ms. Moore advised that occasionally they may go over the \$22,000.00 if they get into a problem that exceeds that amount but those are considered on a case-by-case basis. Ms. Moore advised that the Homeowner Down Payment Assistance program is capped at \$78,000.00. This program's purpose is to increase the number of owner-occupied households. Ms. Moore advised that it is for LMI families to provide a down payment for the purchase of a house. Ms. Moore advised that the deadline to submit the grant is June 21, 2023. Scott Hillis is the grant coordinator and oversees the CHIP Program for Carroll County. Ms. Moore moved on to talk about the Community Development Block Grant (CDBG) Program. Ms. Moore advised that there are national objectives that CDBG projects need to meet. Ms. Moore advised that those objectives are LMI Benefit (determined by the Census and Income Survey), Direct Benefit, and Limited Clientele. Ms. Moore advised that there are areas in the county that qualify automatically if they have 51% or more LMI people. Ms. Moore advised that Direct Benefit is a project that benefits individual households, such as a new septic system. In that case, you qualify the individual household. Ms. Moore advised that Limited Clientele refers to a group of individuals that are LMI based on their status, such as abused children, battered persons, senior citizens, severe illiterate people, homeless, and disabled adults. Commissioner Modranski asked if the project must benefit that clientele only or can it benefit other people as well. Commissioner Modranski gave an example regarding a handicapped bathroom at a park that would benefit other people as well as someone who is handicapped. Ms. Moore advised that in that case, the project would be considered since it is a public facility and would benefit handicapped individuals as well as everyone else. Tom Konst, Regional Planning Director asked Ms. Moore if the project benefits a specific group, the survey would not be needed. Ms. Moore advised that is correct. Ms. Moore advised that another national objective is the prevention or elimination of slum and blight. This grant is mostly used for downtown grants or building demolition projects where you are trying to improve an area or remove a building that is considered a hazard. Ms. Moore advised that the allocation program is an automatic grant that the county applies for and if the projects qualify, the county receives the money. The grant application is due to the state by June 14, 2023. Ms. Moore advised that Carroll County qualifies for \$150,000.00, which includes administration and the mandatory fair housing program that the ORDC handles. There is also \$120,000.00 that can be used for project or planning costs. Ms. Moore advised that every five years, the county must do an analysis of impediments to Fair Housing. The last one was done in 2019 and is due again in 2024. Ms. Moore advised that it could be paid for as a planning activity with the allocation grant. Ms. Moore advised that it will need to be done this year because the program is for 2023 and 2024. Commissioner Modranski asked if the cost to do the analysis comes out of the \$150,000.00. Ms. Moore advised that it comes out of the \$120,000.00 project costs but it does not count as a project. The county is eligible to do two projects. Ms. Moore advised that last year the state allowed three projects, but they lowered it this year because they want the county to do bigger projects that offer more impact. Ms. Moore advised that there is no minimum price for projects, and you can just do one project if all the funding is needed for that project. Ms. Moore advised that you can no longer use any of the funds for street work, such as resurfacing. The project applications from the county will be due May 18, 2023, by 1:00 pm. Commissioner Modranski asked who should be applying for the grant. Ms. Moore advised that any stakeholders or non-profits can apply. Commissioner Modranski asked if it was still the "rule of thumb" that you apply for grant in 2023 and you receive the money in 2024. Ms. Moore advised that usually receive the grant agreement in October and typically everything is completed, and the funds are available by February. Ms. Moore advised that there are still several competitive grants, and the first-round applications are June 14, 2023. A second round will be done for remaining funds. These grants include a Neighborhood Revitalization Grant in the amount of \$750,000.00 for project to improve the quality of life, livability and functionality of distressed areas and neighborhoods. Ms. Moore advised that resurfacing and paving are eligible in this grant, but it must be a distressed area or neighborhood. The

Critical Infrastructure Grant in the amount of \$500,000.00 is for projects designed to assist communities with high-priority, single component projects, such as flood and sewer, structural road improvements and bridges. Ms. Moore advised If it is a small water or

Critical Infrastructure Grant in the amount of \$500,000.00 is for projects designed to assist communities with high-priority, single component projects, such as flood and sewer, structural road improvements and bridges. Ms. Moore advised If it is a small water or sewer project, it should be applied for under critical infrastructure. If the project exceeds more than \$650,000.00, it should be applied for under the larger Public Infrastructure Grant. Ms. Moore advised that the Economic Development Loan program will be retained and is used to create and retain jobs for LMI persons. The Residential Public Infrastructure Grant is used to create safe and sanitary living environments through the provision of safe and reliable drinking water and proper disposal of sanitary waste. Commissioner Modranski asked if the project had to be for both water and sewer. Ms. Moore said no, it could be one or the other. Ms. Moore advised that the Target of Opportunity Grant Program includes the Downtown Revitalization Grant in the amount of \$250,000,00, which is to improve Central Business Districts and aid in elimination of slum and blight. Ms. Moore advised that you could do up to three projects or the money could be used to revitalize one large project. Typically, business owners are asked to pay half of the project but that is at the discretion of the commissioners. Ms. Moore that the Target of Opportunity Grant is for projects that don't fit other categories and are reviewed on a case-by-case basis. These grants are not capped and can be used for economic or community developments. The New Horizons Fair Housing Assistance - Set Aside program is a \$15,000.00 grant to provide funds to affirmatively further fair housing and eliminate impediments to fair housing. The Ohio Housing Trust Fund Target of Opportunity provides funding for operations in permanent supportive housing and facility-based transitional housing programs for LMI citizens. The Homelessness Target of Opportunity grant includes the Supportive Housing Program and Homeless Crisis Response Program to help the homeless in the community. Ms. Moore advised that all these programs are under the CDBG umbrella, and the county is eligible to apply for any of them. If the village wants to apply for any of the grants, they will have to go through the commissioners, they are not eligible to apply for them on their own. Ms. Moore advised that all the programs come with fair housing requirements. Ms. Moore advised that a Community Development Implementation Strategy (CDIS) meeting will be held on Thursday, April 20, 2023, at 7:00 p.m. in the Village of Carrollton Municipal Building. This meeting will be for interested stakeholders to ask questions about the program. Commissioner Modranski asked if all the villages and townships would be invited to this meeting and Ms. Moore answered yes. Ms. Moore believes that an e-mail gets sent out to all the fiscal officers and the mayors. Everyone is welcome to attend. Ms. Moore advised that once projects have been chosen, the commissioners will make a recommendation on what projects fit into the programs that will be applied for on June 14, 2023. There will be a second public hearing where the decision will be announced, and the public will have a chance to provide feedback or ask questions. Ms. Moore advised the hearing date will be set after they figure out the prospective projects. The second hearing date will be published. Ms. Moore moved on to discuss Fair Housing. Ms. Moore advised that the ORDC office does outreach and training for Fair Housing, as well as answering phone calls in their office. A lot of the calls they get are not fair housing issues, but rather landlord-tenant issues and they cannot answer those questions because they are not attorneys. However, Ms. Moore advised that they do direct those callers to the appropriate numbers to get them assistance. Commissioner Wirkner asked if a person was to call 211, would ORDC's services be listed in the directory. Ms. Moore does not think so because their service only extends to contracted counties. Ms. Moore advised that they get calls from counties that they do not serve, and they try to direct those callers to the right person in their county. Commissioner Modranski asked Ms. Moore if her outreach material had her contact information on it, she said yes. Commissioner Modranski advised that a lot of times we get calls at the commissioners' office and the clerks will transfer them or provide resources to the caller. Ms. Moore advised that the Fair Housing component is a requirement because the money for the programs comes from the federal government. Ms. Moore advised that ORDC complies with the Fair Housing mandate by doing short presentations in the counties and providing brochures with fair housing information. More realtors and landlords are requesting fair housing meetings. Ms. Moore advised that the Fair Housing information is provided so that people know they have the right to live where they want as long as it's within their means. There are seven protected classes for fair housing: age, religion, color, national origin, gender, familial status, and disability. Ms. Moore advised that Ohio has added two more classes: military veterans and ancestry. Discrimination can include charging more for rent, higher mortgage rates, or a realtor refusing to show a house. Ms. Moore advised that if someone feels they are being discriminated against, they should call the ORDC office. There is an intake form that gets filled out to determine if it is a fair housing issue or a landlord-tenant issue and then their office proceeds accordingly. Mr. Konst advised that a lot of times he gets calls in his office and refers them to Julie Kiser at ORDC. Mr. Konst advised that Carroll County's HUD houses are managed by the Stark County Metropolitan Housing District, so any calls regarding HUD should be referred to them. Mr. Konst advised that any landlord-tenant issues can be referred to Southeast Legal Services in Steubenville. Commissioner Modranski asked if Southeast helped low-income families and Mr. Konst advised yes. Commissioner Modranski stated that he wanted viewers to know that there was free legal help available. Commissioner Modranski asked Ms. Moore if a landlord can refuse to rent to someone because of the number of family members. Ms. Moore advised that there could be limits if the dwelling is too small to hold the number of family members. Commissioner Modranski closed the public meeting at 10:07 AM.
