

Alison Redman, County Risk Sharing Authority (CORSA) Membership Services Manager and Chris Jones, McFadden Insurance agent appeared before the Board to discuss the 2023 CORSA renewal. Ms. Redman presented her report that reflects the renewal for 2023. A copy is on file at the commissioner's office. Ms. Redman advised that the highest cost with this renewal is with the reinsurance market. The reinsurance market is getting harder to find a company to work with. There were only three reinsurance companies who were interested in working with CORSA. Ms. Redman advised that CORSA has been able to retain a reinsurance company. Ms. Redman advised that the increase in CORSA program costs is 10%. This is still lower than private market which is seeing a 15% to 20% increase in costs. Carroll County's increase in costs is 8.1% which is below than the 10% increase. Ms. Redman advised that reinsurance companies are tightening on cyber security requirements. CORSA is offering funds for cyber security improvements including anti-phishing programs and Multi-Factor Authentication. Ms. Redman advised that the county's discount on 2023 costs come from participating in the Loss Control Incentive Program and the return of member equity in the form of a dividend. Ms. Redman advised that Carroll County is due for its appraisal this year. Commissioner Wirkner asked why is there an issue with the reinsurance companies. Ms. Redman answered that the two larger issues are weather related damages and civil suits against law enforcement. Mr. Jones advised that we are currently in a hard market for reinsurance. Commissioner Wirkner asked if it is an issue of the program being too large of a liability for companies to cover. Ms. Redman answered no, there are multiple pools that spread out the liability before it goes to the reinsurance market. Ms. Redman advised that the size of the program is actually helping. Mr. Jones thanked the Commissioners' clerks for their help with processing claims.
