JAIL WINDOW PROJECT

Ed Eick, Superintendent of Buildings and Grounds advised that he would like to give an update regarding the jail window project and publicly thank the Carroll County Messenger for allowing courthouse contractors to use their parking lot during the jail window project. Mr. Eick also thanked Ken Joseph on behalf of himself and the Board for allowing his parking lot to be used as a staging area, which allowed the project to be done in a simplified manner. Mr. Eick advised that 37 windows have been installed and there are only nine windows left to install. Mr. Eick advised that not all the windows that were installed are fully complete, some still have touch ups to be done. Mr. Eick advised that he is meeting with the Department of Corrections today to discuss the window tint regulations. Mr. Eick anticipates that the project should be completed in the next two weeks. Commissioner Modranski commented that the beautiful thing about Carroll County is how neighbors help each other, not even hesitating when asked to use their property.

Commissioner Wirkner asked if the tint issue was only for the ground floor windows. Mr. Eick advised that the Department of Corrections will answer this question today. Mr. Eick advised that the windows were tinted to the compliancy of allowing natural light to come in as specified. The issue is the height of the windows. Mr. Eick advised that when a new building is built, the window ledge is not to be below six-foot grade. Mr. Eick advised that Fairfield County had the same issue with their windows being below the six-foot grade and they had to have additional tint applied to the windows and the cost wasn't significant. Mr. Eick advised that he will know more after he meets with the Department of Corrections. Commissioner Wirkner asked if we only had two to three windows at ground level. Mr. Eick advised that there are approximately ten windows on the backside that are ground level. Mr. Eick advised that one of the cell blocks are almost roof level with one building, and several windows are eye level with windows of a house on the east side. Mr. Eick advised that he met with the engineer and the Department of Corrections in the beginning, and they could not have the windows manufactured with darker tint. Mr. Eick advised the engineer, and the Department of Corrections were referring to the code books, which did not take into consideration the height of the windows. Commissioner Modranski asked if the Department of Corrections would supply an answer today at their meeting. Mr. Eick answered yes. Commissioner Modranski advised that it may just be as simple as adding tint to the windows. Mr. Eick advised that Fairfield County had to pay \$13,000.00 for 146 windows to be tinted. This project only has a total of 46 windows, and it shouldn't cost more than \$5,000.00 to have the ones tinted that may need to be. Commissioner Modranski advised that the county was recently awarded \$226,000.00 towards the jail project. Commissioner Wirkner advised that the funding will help but it will not cover the cost completely. Commissioner Modranski advised that it will cover a large portion of the cost.

IN THE MATTER OF NEXT GENERATION 9-1-1

Commissioner Wirkner advised that when the county went to Next Generation 9-1-1, the cost of the equipment was so high, that the county entered a cost sharing program with several counties for equipment at the Security Operations Center (SOC). Commissioner Wirkner advised that the equipment needs upgraded now. The options are for the county to buy equipment on its own and it would cost just under a million dollars or continue to share the cost of equipment with other counties that are in the same ESInet. Commissioner Wirkner advised that the option to continue to share the cost is going to be presented to the committee. Commissioner Wirkner advised that the upgrade is going to cost around \$30,000.00 if everyone continues to cost share. Commissioner Wirkner advised that the county will still owe its continuing commitment for the equipment that it had. Commissioner Wirkner advised that the county will still owe its continuing commitment for the equipment Modranski advised that there is a piece in the legislature right now to increase the Next Generation 9-1-1 funding. Commissioner Wirkner advised that it was originally believed that the purchased equipment would carry the county through until the state was ready to unveil the Next Generation 9-1-1 statewide and that has not happened yet. Commissioner Wirkner advised that the equipment was not anticipated to be needed this long. Commissioner Wirkner advised that you can consider the upgraded equipment a pilot program extension until the state mandates statewide Next Generation 9-1-1.
