estimated 200 deaths, 975 injuries and over \$1.1 billion in property loss. Mr. Nuzzolillo advised that Ohio State Fire Marshal shared some valuable safety tips to keep your home fire-safe. Some tips include: always plug major appliances, like refrigerators, stoves, washers and dryers, directly into a wall outlet; use light bulbs that match the recommended wattage on the lamp or fixture; do not overload wall outlets; never force a three-prong plug into a two-slot outlet; use extension cords for temporary purposes only; and avoid putting cords where they can be damaged or pinched, like under a carpet or rug. Mr. Nuzzolillo advised that these tips and others can be found on the Federal Emergency Management Agency's home fire prevention website at www.usfa.fema.gov/prevention/home-fires/. Commissioner Leggett advised that he has been discussing consultant services with McGohan Brabender, who is currently the county's broker for voluntary benefits. Commissioner Wirkner advised that the 9-1-1 Technical Services Advisory committee and the 9-1-1 Planning committee met recently and have three issues to present to the Board of Commissioners for ratification. First, Carroll County is part of a pilot program with NextGen 9-1-1. At the time the program was kicked off, it was it was believed that the State of Ohio would mandate NextGen 9-1-1 by this time. That mandate has not happened yet, and the equipment at the state operations center (SOC) needs updated. Commissioner Wirkner advised that the options for member counties are to either buy their own equipment, which will cost approximately \$1 million, or go with the second option, which is all member counties contribute to the upgrade at the SOC. Commissioner Wirkner advised the cost to members counties is \$29,820.89, and the other member counties have chosen this option. It is the recommendation of the Technical Services Advisory committee and the Planning committee that Carroll County pays their share of the equipment upgrades at the SOC in the amount of \$29,820.89.
