Commissioner Modranski advised that it is time to open the second public hearing for the PY23 CHIP. Dale Hartle, Ohio Regional Development Corporation (ORDC) President opened the 2nd public hearing for the Community Housing Impact and Preservation (CHIP) program at 9:30 a.m. Mr. Hartle advised that the first program is the Homeowner Rehabilitation program. The sources for the funds for this project are CDBG and HOME. The maximum amount allowed for this program is \$75,000 per home. The homeowner must be at 80% Low to Moderate Income (LMI) or less. There is a five-year declining mortgage for Home Rehabilitation projects. The mortgage declines by 20% for each year of the five-year term. The Rental Rehabilitation program is similar to the Homeowner Rehabilitation program. It too, has a \$75,000 maximum amount per home. The homeowner has to meet the financial requirements of 80% LMI. The landlord would have to contribute 50% of the project costs. Homeowner Rehabilitation projects do not have the requirement for the homeowner to contribute. The Owner Home Repair project is a grant not a mortgage. The maximum amount for Home Repair projects is \$22,000 per home. The income requirement for these projects is also 80% LMI. The Rental Repair program is the similar to the Home Repair. For these projects, the landlord contributes 50% of the project costs. The Homeownership Down Payment Assistance program helps those who are wishing to buy a house by covering the down payment. The income level for this program is 80% LMI. The maximum amount allowed for this program is \$78,000. The home does need to meet the residential rehab standards. To meet those standards, funds may come out of \$78,000 to make any necessary repairs. The Tennant Based Rental Assistance program is modeled off of the Section 8 voucher plan and is typically managed through the Metropolitan Housing Authority. Mr. Hartle provided the income guidelines for CHIP projects. If there is one person in the

household, their income can be \$46,050 or less to be eligible. Households with two people can have an income of \$49,200 or less to be eligible, and households with three people can have an income of \$55,350 or less to be eligible. Mr. Hartle provided a handout that shows the various income levels. Mr. Hartle advised that the proposed budget for PY23 is \$232,000 for Homeowner Rehabilitation projects. This would allow three projects and would benefit nine recipients. \$125,000 is the budget for Homeowner Repair projects. This would allow six projects to help 18 recipients. This is assuming that we are paying the maximum amount for each project. It is typical not to spend the entire \$18,000 on repair projects. ORDC is estimating to complete six projects but may be able to get up to 10. Mr. Hartle advised that the Homeowner Repair Projects are first come first serve. Home Repair projects are designed to be for emergency repairs. For example, it is in the middle of January and the furnace goes out. The Homeowner Rehabilitation projects are weighted on the basis of the need of the project. Once an applicant is qualified by income, the housing specialist will then go to each property and determine the need for each project. Points are awarded by needs of the project and the demographics of the applicant household, for example: elderly, handicapped, with children. CHIP is a two-year program. Applications for the grant from the state are due June 1st. Carroll County should get a response in October or November. Commissioner Modranski asked if mobile homes are eligible for the Homeowner Rehabilitation program. Mr. Hartle answered not for the Homeowner Rehabilitation program, but it may be eligible for the Homeowner Repair program. Commissioner Modranski asked what happens if a tenant qualifies for LMI, and the landlord pays the 50% of the costs, and then the tenant moves out and is replaced by someone who does not qualify for LMI. Mr. Hartle answered that the landlord would be responsible to pay for the remaining 50% of the costs. If the LMI qualified tenant leaves and is replaced with another LMI qualified tenant, there is no need for the landlord to pay the remaining 50% of the costs. Commissioner Modranski asked if the three Homeowner Rehabilitation projects have been completed, and the county hasn't spent the entire \$232,000 allocated for the program, can those funds go towards additional Homeowner Repair projects? Mr. Hartle answered, that depends what needs to be done. Homeowner Repair projects are funded by Community Development Block Grant (CDBG) and Ohio Housing Trust Funds (OHTF) funds. Mr. Hartle advised that CDBG funds are versatile and can be used for a variety of projects. Homeowner Rehabilitation projects are funded primarily with HOME funds which are more limited on how they are used. The extra funds can be used for a Repair project by using an amendment, but they would still have to follow the HOME guidelines. Mr. Hartle advised that if there are extra funds left over, ORDC will look at remaining applications to see if any would fit within the remaining budget. Ronald M. Nuzzolillo Jr, Director of Special Projects stated that the office is already receiving phone calls from residents who would like to apply for the next round of CHIP funding. Mr. Nuzzolillo asked when applications would be ready for residents. Mr. Hartle answered that applications will not be ready to go out until the beginning of next year or possibly the end of this year. It is not recommended to send out applications until the county has been approved for the PY23 grant. Mr. Nuzzolillo asked if there are residents who are interested in the CHIP program, but applications are not ready, should the office create a waitlist of prospective applicants, or should the office wait until applications are ready to go out. Mr. Hartle advised that the county should wait until applications are ready, and the award announcement has been made. Commissioner Modranski stated it would be fair for all if there was no waitlist and to collect applications once the award is made and applications are ready. Commissioner Modranski recommended that residents who need assistance to utilize 2-1-1 to see what other services are available in the area. Commissioner Modranski stated that it will be at least a year and a half until the PY23 CHIP projects will begin. There are some residents that may not be able to wait that long for their project. Commissioner Wirkner stated that we don't want to create unrealistic expectations when there are other programs available. The public hearing closed at 9:48 a.m.
