Commissioner Wirkner provided an update on the state budget. Commissioner Wirkner advised that the Indigent Defense Fund is not getting funded as promised. Commissioner Wirkner advised that, in the last quarter, the reimbursement was at 68% which is far from the promised 90%. The reason for the shortage is counties have requested funds that are higher than what was planned for by the state. Commissioner Modranski asked if this is statewide. Commissioner Wirkner answered yes. Commissioner Wirkner advised that, despite the increase in the Local Government Fund (LGF) in the budget, due to changes in the tax collection, there will be a reduction of funds from the LGF to the counties. Commissioner Wirkner advised that one of the Governor's budget requests was reimbursement for the MARCS radio user fees. The latest version of the budget bill did not include the MARCS radio reimbursement. Commissioner Wirkner stated that the Indigent Defense reimbursement is an important issue for the county. Commissioner Modranski asked if the County Commissioners Association of Ohio (CCAO) has been reached out to. Commissioner Wirkner advised that CCAO has been sending info out to the counties. Commissioner Wirkner stated is should be the state, not the commissioners, to fund the Indigent Defense Fund.
