IN THE MATTER OF **RESIDENT CONCERN SUNSET VALLEY ROAD**



John Vittling, Carroll County resident appeared before the Board with a complaint regarding a road right-of-way in Sunset Valley where he has lived since 1973. Mr. Vittling advised that there is a blockade on Maple Street that divides Sunset Valley from Woodside Drive in Atwood Village. Mr. Vittling advised that he lives on Walnut Road. He does a lot of walking and he decided to weed eat the weeds on Maple Road where the blockade is, so he doesn't have to walk in the weeds. Mr. Vittling advised that the

residents who live there threatened to call the police and have him arrested for trespassing, stating that they own that property. Mr. Vittling advised that Maple Road has a right-of-way for all public utilities, and he asked the Board if he was trespassing. Mr. Vittling advised that Sunset Valley residents have removed the blockade twice, but Atwood Village residents reconstructed it to keep people from driving on Woodside Road. Mr. Vittling advised that there are people who use the right-of-way to drive golf carts from both villages and he just wants to be able to walk it. Mr. Vittling advised that the map shows that it is a 25-foot right-of-way and that it is a dedicated road. Mr. Vittling advised that there is only one way out of Sunset Valley and one way out of Atwood Village, which poses an issue when there is an emergency. Mr. Vittling advised that there was a fire and fire trucks blocked the road for five hours and no one could get out. His opinion is that the blockade needs to be removed and the road be able to be used in case of emergency. Commissioner Modranski asked Mr. Vittling if he had visited the map office and he said yes. Commissioner Modranski asked him what the map office told him. Mr. Vittling advised that Woodside Road and Maple Road are both dedicated roads. Commissioner Wirkner advised that any threat of trespassing needs to be taken up with the Sheriff's office. Commissioner Wirkner asked Mr. Vittling what road he lived on. He advised that he lives on Walnut. Commissioner Wirkner asked Mr. Vittling how wide the easement is on Walnut. Mr. Vittling advised that it is 20 feet wide. Commissioner Wirkner asked him how much of the easement he maintains, and Mr. Vittling advised that he does not maintain any of it. Commissioner Wirkner advised that he still feels like this is an enforcement issue which involves the Sheriff. Mr. Vittling advised that according to the Commissioners' website, only the Board can open or close roadways. Mr. Vittling asked if the commissioners can have the Engineer look at the road to determine if it is a public right-of-way. Commissioner Wirkner asked Mr. Vittling if he established that no one owns the roads in Sunset Valley, and he said yes. Commissioner Wirkner asked about the adjacent road. Mr. Vittling advised that he only knows that people in Atwood Village placed the blockade because they did not want people from Sunset Valley driving on it. Commissioner Modranski advised that he will talk to the County Engineer, and he will let Mr. Vittling know what is determined.
