Sonja Trbovich, Transit director appeared before the Board to present changes to the Americans with Disabilities Act (ADA) plan. Ms. Trbovich advised that the Ohio Department of Transportation (ODOT) has the no-show policy and suspension appeals in with the ADA plan. There have been changes these items due to recurrent, habitual no shows. Ms. Trbovich advised that it costs money to go out. Currently, the no show policy states that the first offense in 30 days is a verbal warning, second offense is a letter, and third offense is a one-day suspension. ODOT's new recommendation is that passengers with no shows equal to or greater than 25% of their scheduled rides in a 30-day period will receive a written warning. In order to be considered for a written warning, the passenger must be booked for three trips or more in a calendar month. The first violation in a rolling 12-month period is a verbal warning, the second violation is a warning letter, the third violation is a seven-day suspension, fourth violation is a 14-day suspension, the fifth violation is a 21-day suspension, sixth and subsequent violations in a rolling 12 month period is a 30 day suspension. Commissioner Modranski asked what is considered no show. Ms. Trbovich advised anything less than a two-hour notice for cancellation. Commissioner Wirkner asked what the appeals process is, and can riders continue to ride during the appeal period. Ms. Trbovich advised that yes, they can still ride during appeals. Appeals are submitted in writing to Ms. Trbovich. There is a Transit Appeals Committee that Ms. Trbovich can present major issues to. The committee would then make a recommendation that would then come to Board of Commissioners. Ms. Trbovich advised that riders have seven days to appeal. Commissioner Wirkner asked Ms. Trbovich plans to handle the rolling 12-month period and how to determine the look back. Ms. Trbovich advised that she plans to start now and move forward without a look back. Commissioner Modranski advised that he agrees. It is a new policy, so just start now. Commissioner Leggett asked how many cancellations there are. Ms. Trbovich that riders cancel all the time.
