Alison Redmond, County Risk Sharing Authority (CORSA) Membership Services Manager and Chris Jones, McFadden Insurance agent appeared before the Board to provide an update on the 2023 building appraisal for the county. Mr. Jones advised that the last appraisal was completed in 2019. The county will be receiving a hard copy and a digital copy of the appraisal. Ms. Redmond passed out a Summary of Appraisal. Ms. Redmond advised that CORSA provides the appraisal as a member benefit. The cost of the appraisal is \$9,410.00 and is a value-added service. Mr. Redmond advised that the appraisal evaluates all buildings over \$100,000.00. Anything under \$100,000.00 is calculated as trending. If the Board feels there is a building that should have been appraised, they should let Mr. Jones know. Ms. Redmond advised that HCA Asset Management did Carroll County's appraisal and did a wonderful job. Mr. Jones advised that HCA Asset Management did the appraisal on the Moody Avenue building even though the county did not own the building yet. Ms. Redmond noted that appraisals can be done even if it's not an appraisal year. CORSA would have an appraiser come do a new building when they are in the area. Ms. Redmond noted that the Total Insured Value before the appraisal was \$78,595,640.00 and the new Total Insured Value after the appraisal is \$95,418,847.00. The increase is 21.40%. Mr. Jones advised that half of the increase is due to the purchase of the Moody Avenue building, and the rest of the increase is an increase that has been seen across the board. The premium increase is \$9,561. Ms. Redmond advised that it is too soon to know the exact renewal number but the county should plan on a 10% increase for 2024 for budgetary purposes. Ms. Redmond advised that should be a safe number to use. Ms. Redmond advised that the Board needs to complete the Property Valuation Selection form and return that to CORSA. This form is where the Board indicates if they want the courthouse covered at replacement cost or reproduction cost. The replacement cost of \$21,113,400.00 is to replace the building at today's standards. The reproduction cost of \$32,105,300.00 is to replace the building as nearly as possible to its original condition. Ms. Redmond advised that choosing replacement will save \$5,496. Commissioner Modranski asked what steps should be taken if the county sells property. Ms. Redmond advised that the county should inform Mr. Jones and he will make the necessary adjustments.
