Commissioner Wirkner advised that he has been receiving calls from residents about Tenaska, Inc. Commissioner Wirkner stated that the commissioners do not endorse Tenaska's operations. The Board is only providing an update of activity in the county. Commissioner Wirkner recommended residents do their due diligence when deciding to enter into a contract with Tenaska, such as doing research about the company. Commissioner Wirkner also recommended that, similar to oil and gas leases, residents should talk with their neighbors to ensure all are getting a fair deal. Commissioner Wirkner recommended that residents seek legal help if they are unsure of entering into a contract with Tenaska.

CCAOSC ENERGY COMMITTEE MEETING



Commissioner Wirkner advised that he attended an energy summit through CCAO. Commissioner Wirkner advised that the purpose of the county consortium is to pool together resources to keep prices low. Commissioner Wirkner advised that 61 counties pooled together for natural gas, and 59 counties pooled together for electric. Commissioner Wirkner stated that the county started in the program back in January 2016. When the program started, the savings were modest due to a stable market. However, that has changed recently. Commissioner Wirkner advised that by joining the pool, the county has saved \$157,730. The reason behind the savings is due to the volatility of the market. Besides pooling resources, the county also saved money by hedging funds to cover any increase in costs. Commissioner Wirkner advised that in the 2024-2025 program year, the cost of electric generation will go up 22%. Because the county is pooled and has the hedge, the county will still continue to save money. Commissioner Wirkner advised that he spoke with other counties who are considering offering residents the option to aggregate electric costs. Commissioner Wirkner stated that there has been confusion between generation costs and transmission costs. Many residents in the county do not have the benefit of pooling in an aggregate for generation costs. Commissioner Wirkner suggested the Board should consider offering

residents the option to aggregate. Georgett Huff, Free Press Standard asked how would that work. Commissioner Wirkner advised that there would be a ballot initiative that the voters would have to approve. Residents who already are in an aggregate, such as residents in the village of Carrollton, would not be included. Commissioner Wirkner advised that the first step is to see if the Board has any interest. Commissioner Leggett asked if this would leave out residents who are part of the co-op. Commissioner Wirkner answered no, he doesn't think so. Commissioner Wirkner stated that the residents will need to have a say whether they wish to aggregate or not. Ms. Huff stated that this would be confusing because not everyone has natural gas. Commissioner Wirkner advised that this would be for electric only. Commissioner Wirkner stated the reason for focusing on electric is due to the rise in costs of electricity. Ms. Huff asked if electric costs are really going up that much. Commissioner Wirkner answered yes, they are estimated to go up by 22%. Ms. Huff asked if the same energy provider serves the entire county. Commissioner Wirkner advised that a RFP would go out to various electric generators. A decision would be made to sign a contract with the generator who can provide electric at the lowest amount. Commissioner Wirkner advised that Palmer Energy is the administrator for the CCAO energy policy. The administrator also set up the hedge to keep costs low. Ms. Huff asked besides AEP and the co-op, who else provides electric in the county. Commissioner Wirkner stated that he knows there are others in the county but is not sure of the names. Commissioner Wirkner advised that he wanted to see the Boards interest before moving forward.
