Ms. Faulk advised residents to check out the CGAR Facebook page as the activity staff does a great job of keeping up with daily pictures of residents. Ms. Faulk advised there were three new admissions and one respite stay in October. There are 25 females and seven males for a total of 32 residents. Ms. Faulk reminded viewers that CGAR does respite stays that last from a few days to a few weeks for residents who need care while family members are away or cannot care for them.

SUICIDE FATALITY REVIEW COMMITTEE

Kelly Morris, Health Commissioner and Natalie Bollon, ADHAMS Board Director appeared before the Board to discuss a Suicide Fatality Review Committee. Ms. Morris advised that there have been increases in suicide across the state. Ms. Morris advised that this is an optional review committee that the commissioners appoint the county Health Commissioner to be the chair of, and the

committee will review the fatalities that are related to suicide. Ms. Morris advised that the purpose of the committee is to look for root causes of the suicides and start some prevention programming. Ms. Bollon advised that the committee's preventative measures are based on the data that is collected. Ms. Bollon advised that individuals who come into the county and commit suicide are not counted in the numbers for Carroll County. Ms. Bollon advised that there has been a little bit of decline in suicides over the past five years. Ms. Bollon advised that the age range with the second highest rate of suicide is 25 to 34 years of age, and the highest rate is among those individuals who are 65 years and older. Ms. Bollon advised that men outpace women in suicides by three to one, typically because they are using more deadly measures, while women are using medication. Ms. Bollon advised that they would appreciate the commissioners' support. Commissioner Modranski asked Ms. Bollon if the data that she presented was from the state or the county. Ms. Bollon advised that the decrease in suicides pertains to Carroll County, but the gender and age rate is statewide. Ms. Morris advised that there have been three suicides this year in Carroll County. Ms. Morris advised that the coroner responds to all suicides, but he is not required to be on the Suicide Fatality Review Committee. Ms. Morris advised that she already had a conversation with Dr. Haas. Dr. Haas indicated to Ms. Morris that he would be on the committee and he feels that it is needed. Commissioner Modranski asked how many people would be on the committee. Ms. Morris advised that the Ohio Revised Code states that the Health Commissioner would appoint four additional members to the Child Fatality Review Committee. Ms. Morris advised that she would like to appoint the same six members that are on the Child Fatality Review Board. The Suicide Review committee could meet yearly immediately after the Child Fatality Review Board meeting. Ms. Morris advised that if they see an increase in suicides, they will meet more frequently. Commissioner Modranski asked if services would be tailored based on the data. Ms. Morris advised that there would be a database and reporting of suicides. Ms. Bollon advised that prevention is a big part of this, and the goal is to stop suicide and destigmatize mental health services. Ms. Morris asked Ms. Bollon to talk about the "Check Your Engine" program that is geared towards helping farmers and the increased suicide rate among the agricultural community. Ms. Bollon advised that the agricultural community across the state of Ohio has one of the highest suicide rates among any profession. Ms. Bollon advised that the ADHAMS Board partnered with the Regional Farm Bureau and brainstormed ways to speak with farmers about mental health in a way that won't scare them off. Ms. Bollon advised that they came up with the "Check Your Engine" Program to relate to farmers. Ms. Bollon advised that and the goal is to do outreach to farmers and their families to reduce that suicide rate.

RESOLUTION 2023-36

A RESOLUTION SUPPORTING THE FORMATION OF A SUICIDE FATALITY REVIEW COMMITTEE FOR CARROLL COUNTY

WHEREAS, the Ohio Revised Code Section 307.641 allows for the establishment of a Suicide Fatality Review Committee to review deaths by suicide occurring in the County; and

WHEREAS, in accordance with the Ohio Revised Code Section 307.641 (A), a board of county commissioners may appoint the health commissioner to establish the Suicide Fatality Review Committee; and

WHEREAS, the health commissioner shall select four members to serve on the committee in accordance with Ohio Revised Code Section 307.642 (A)(1); and

Whereas, in accordance with Ohio Revised Code Section 307.644, the Commissioners shall designate either the Health Commissioner or a representative of the health commissioner to convene meetings and be the chairperson of a suicide fatality review.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Carroll County, Ohio with at least two-thirds of its members thereto concurring as follows:

SECTION 1. The Board of Commissioners of Carroll County, Ohio hereby appoints the Health Commissioner of the Carroll County Health Department to establish the Suicide Fatality Review Committee in accordance with Ohio Revised Code Section 307.641 (A). **SECTION 2.** The Health Commissioner of the Carroll County Health Department shall select four members to serve on the committee in accordance with Ohio Revised Code Section 307.642 (A)(I) as follows:

a) The chief of police of a police department in the county or region or the county sheriff or a designee of the chief or sheriff;

b) A public health official or the official's designee;

c) The executive director of a board of alcohol, drug addiction, and mental health services or the executive director's designee;

d) A physician authorized under Chapter 4731 of the Revised Code to practice medicine and surgery or osteopathic medicine and surgery.

SECTION 3. The Board of Commissioners of Carroll County, Ohio hereby designates the Health Commissioner of the Carroll County Health Department, or designee, to convene meetings and be the chairperson of the Suicide Fatality Review Committee in accordance with Ohio Revised Code Section 307.644.

SECTION 4. The Suicide Fatality Review Committee is given the charge to decrease the incidence of preventable suicide deaths by doing all of the following:

a. Promoting cooperation, collaboration, and communication between all groups, professions, agencies, or entities engaged in suicide prevention, education, or mental health treatment efforts;

a) Maintaining a comprehensive database of all suicide deaths that occur in the county or region served by the review committee in order to develop an understanding of the causes and incidence of those deaths;

b) Recommending and developing plans for implementing local service and program changes and changes to the groups, professions, agencies, or entities that serve local residents that might prevent suicide deaths;

c) Advising the department of health of aggregate data, trends, and patterns concerning suicide deaths.

RESOLVED FURTHER that this Board of Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board which resulted in this formal action were taken in meetings open to the public in full compliance with applicable legal requirements, including ORC 121.22.
