Ralph Castellucci, Director of Environmental Services appeared before the Board to request an increase in user fees for the Carroll County Environmental Services. Mr. Castellucci advised that there has not been an increase in seven years. Mr. Castellucci advised that the state average for wastewater utilities has increased over 24 percent since 2017. Mr. Castellucci advised that there are major improvements to the pump stations that he would like to get completed over the next year. Mr. Castellucci advised that Carroll County Environmental Services maintain over 184 pump stations, 5.6 miles of underground electric distribution, 10.7 miles of gravity mains, and 584 purposes like manifold services. Mr. Castellucci advised that he would like to split the increase into two years. Mr. Castellucci advised that there would be a \$3.00 increase per resident monthly, effective March 1, 2024, and then a \$2.00 increase monthly effective March 1, 2025. Commissioner Wirkner asked Mr. Castellucci what the time period was that the state average increased by 24 percent. Mr. Castellucci said over a seven-year period. Commissioner Wirkner asked how Carroll County's rates compared to the state average. Mr. Castellucci advised that historically Carroll County wastewater bills have been half or less than half the state average. Mr. Castellucci advised that this year there is a new way to calculate the cost, but Carroll County is still below the state average. Commissioner Wirkner asked what the percentage of increase would be to a bill. Mr. Castellucci advised that for 2024 it would be a 10 percent increase. Commissioner Leggett asked if Carroll County's rates were still below surrounding county's rates and Mr. Castellucci said yes. Commissioner Modranski asked Mr. Castellucci if the increase would allow him to maintain his current facilities or will there be money for expansion. Mr. Castellucci advised that the sewer plant was expanded 24

years ago and is adequate in size. Mr. Castellucci advised that the increase would allow for maintenance and updating of the existing equipment. Commissioner Wirkner asked Mr. Castellucci how much of the bond from the last expansion is satisfied. Mr. Castellucci advised that in 2000 they signed 40-year loans through the United States Department of Agriculture (USDA) and refinanced those four to five years ago through the Ohio Water Development Authority (OWDA) refinancing project. He believes there is eight years left on one bond and 17 to 18 years left on the other. Commissioner Wirkner asked Mr. Castellucci how much of the income supports debt service. Mr. Castellucci said he would guess that approximately 15 percent. Commissioner Wirkner asked Mr. Castellucci how long he thinks the price increase will cover the increase in costs. Mr. Castellucci advised that it depends on the increase in operation costs, which are unknown but historically they haven't had to raise the cost for seven years. Mr. Castellucci advised that he cannot guarantee seven more years, but he does not anticipate any more increases for a few years. Commissioner Modranski asked Mr. Castellucci how an increase to \$33.00, and then to \$35.00 a month, compares to the state average of monthly charges for residents. Mr. Castellucci advised that the way the state calculated it, the cost is \$60 some dollars a month. Commissioner Modranski asked if that was just for sewer and Mr. Castellucci said yes, just for wastewater. Mr. Castellucci advised that they just changed the rate of calculation, but Carroll County is still lower. Commissioner Wirkner advised that he thinks with the rate of inflation, Environmental Services is just treading water. Mr. Castellucci agreed that they are just maintaining.
