Ronald M. Nuzzolillo Jr, Assistant Clerk I advised that the Carrollton Rotary will be holding their 2nd annual Veterans 5K Run / Walk on Saturday, November 11, 2023. The 5K will be held at the Ashton Event Center located at the Carroll County Fairgrounds. CLERK'S REPORT

Commissioner Wirkner advised that he and the 911 Coordinator had a frank discussion with the Auditor of State's office regarding Carroll County's 911 operations. Part of the discussion involved what right looks like for the funding. Commissioner Wirkner advised that the amount proposed by the Emergency Services IP Network (ESInet) committee was \$0.64 per device that can access 911. That number has been knocked down to \$0.40 and will replace the current wireless funding source. Commissioner Wirkner advised this concerns him because Carroll County is struggling to finance the 911 operations. The State advised him that the people of Carroll County need to have a stake in the game and told him that other communities have levies. Commissioner Wirkner advised that the difference is between having a stake in the game and no game at all if the general fund wasn't funding 911. Last year, the state provided approximately \$125,000.00 in funding, and the county had over \$600,000.00 in 911 expenses. Commissioner Wirkner advised that he would argue that Carroll County does have a stake in 911 and he would like to see the state funding be more robust. Commissioner Wirkner advised that one transition coming from the state is that all public safety answering points (PSAPs) must move to Next Generation 911 (NG911). Carroll County was proactive and has already moved to NG911. Commissioner Wirkner advised that the funding is only available to counties that are forced to make the transition. Commissioner Wirkner feels that the same funding should be sent to counties who were proactive in changing to NG911. Commissioner Wirkner advised that during the call, the Carroll County Final Plan, the Technical Services Advisory Committee, and the Planning Committee were also discussed. Commissioner Wirkner advised that discussion was held regarding how they all work together and how funds are spent. The question was asked if the Final Plan allows state funds to pay personnel. Commissioner Wirkner advised that they can, but there are never enough funds for personnel costs. The state funds are exhausted on the technical side of NG911. Commissioner Wirkner advised that he said Carroll County could not be the only county dealing with the funding issue. Other counties are dealing with this, but the state would not say which other counties are having the issue. Georgette Huff, Free Press Standard report advised that the southern counties don't always have as much money so this must be a burden for them. Commissioner Wirkner advised that there are more and more requirements, policies and protocols added for PSAPs every year. These additions require training and all of this cost money. If it was not for the general fund, Carroll County would have to combine with another county. Commissioner Wirkner advised that Carroll County wants to be in control of their own 911 and not rely on another county that is not familiar with our area. Over the last five years, the state is steadily trimming the number of PSAPs that are available to the public. Five years ago, there were approximately 376 PSAPs including Wright Patterson Air Force Base. Columbiana County had to trim several of their PSAPs out due to the consolidation. Commissioner Wirkner advised that maintaining a PSAP is expensive, and the state wants the ones that exist to have the most value. Commissioner Wirkner advised that the southern counties with no levy have to rely on their general fund to fund 911. Right now, Carroll County is part of the pilot program, and the county's ESInet goes down to Columbus. One item that was discussed was our emergency contingencies. Commissioner Wirkner advised that when everyone goes to NG911, the state will maintain the equipment, and each county will have to join in and that will be expensive. Commissioner Wirkner advised that he is asking for clarity from leadership regarding when that change will happen and how much it will cost. Ms. Huff asked if this is a good idea. Commissioner Wirkner advised that after 911 happened, they needed interoperability. The New York Police Departments, New York Fire Departments and Emergency Management Agencies had the best communication equipment money could buy, but no interoperability. Legislature has mandated that every state PSAP has to be interoperable within the state, then state to state interoperability, extending to all of North America having interoperability. Commissioner Wirkner advised that Carroll County has a secondary PSAP at the Dorothy Long Training Center. If something affects the courthouse and the Dorothy Long Training Center, then Carroll County has interoperability with Columbiana County. If a 911 call rings seven times with no answer, it then rolls over to Columbiana County. Columbiana County has the Carroll County mapping and CAD. Commissioner Wirkner advised if something would happen to the Carroll and Columbiana County PSAPs, there are rollovers beyond that as well. Ms. Huff asked if every county has a PSAP. Commissioner Wirkner advised that Carroll County has one at the Sheriff's office. Most counties have at least one. Commissioner Wirkner advised that he doesn't know of any counties that do not have a PSAP. Commissioner Wirkner advised that Carroll County has a stake in the 911, and they are paying more than their fair share. Commissioner Wirkner advised that the state needs to step up and help counties that do not have a levy. Commissioner Wirkner advised that his suggestion is that counties with levies share funding with the counties that do not have a levy. The state has advised that they plan to evaluate the \$.40 charge during 2024 to determine if the cut was too much. Carroll County has agreed to help with this evaluation by opening their books for the Auditor so they can review the costs.
