# IN THE MATTER OF SAINT VINCENT DE PAUL



Father Jonas Shell from Our Lady of Mercy (OLOM) catholic church appeared before the Board to discuss the rental agreement between the Board of Commissioners and Saint Vincent De Paul. Father Jonas thanked the commissioners for working with them and lowering the rent. Father Jonas advised the purchase of the building happened quickly and then St. Vincent De Paul received a contract lease asking for \$750.00 monthly to rent the space that they had already been using for a long time. Father Jonas said that he knows the lease was lowered to \$500.00 a month, but he is asking if it can be lowered even more. Father Jonas explained that St. Vincent De Paul does everything they do for free. They receive donations of clothing, sort them, clean them, and distribute them to people in need. Father Jonas advised that they work in association with Loaves and Fishes which services about 200 families a month. Father Jonas advised that both Saint Vincent De Paul and Loaves and Fishes work with Job & Family Services (JFS) at times to provide goods for the constituents of the county, so it would be nice for them to be in the same building. Father Jonas advised that they were paying for utilities when OLOM owned the building, and they would still like to pay for the utilities. Father Jonas advised that he realizes there is a cost for the building. Father Jonas advised that it looks like the commissioners are providing a service for the community when it is Saint Vincent De Paul that is providing a service and not only are they volunteering their time and effort, but now they are paying to volunteer their time and effort to provide services for the constituents of Carroll County. Father Jonas advised that he feels it would be reasonable to pay a little less. Father Jonas advised that they do not have a tithing system in their church where they exact tithes from people so it's all a free will offering. Father Jonas advised that they receive an average of \$493.00 a month for Saint Vincent De Paul, so over a year's time, they wouldn't be able to pay the rent. Father Jonas advised that \$400.00 a month would be reasonable. Father Jonas asked about returning to the building after the renovations are done. Commissioner Modranski advised that during renovation, the State of Ohio will not allow anyone to inhabit the building. Commissioner Modranski advised that the building will have to be vacated for a period, probably starting in February. Commissioner Modranski advised that the commissioners are looking to house the Board of Elections in the part of the building that Saint Vincent De Paul and Loaves and Fishes are currently occupying. Commissioner Modranski advised that if the commissioners can bring Saint Vincent De Paul and Loaves and Fishes back to the building after the renovations, they would be placed in the back of the building somewhere. Commissioner Modranski is not sure that would work well for people coming and going and the commissioners don't really know what everything will look like until they receive the designs from the architect. Commissioner Modranski advised that the only thing they know for sure is they want to put the Board of Elections in the front of the building and JFS in the gym and some of the classrooms. Commissioner Modranski advised that he fully understands the benefit of what the program does for JFS and the school CARE team. Commissioner Modranski advised that he is hesitant because there are so many churches in our community that do mission work, and if the commissioners allow Saint Vincent De Paul to occupy the building for free or at a discounted rate, then they would be expected to do that for everybody. Commissioner Modranski advised that there are also expenses tied into it. Commissioner Leggett advised that if the commissioners cannot afford to renovate the entire school, including the bathrooms, the State of Ohio will not allow them to lease the unfinished portion. Commissioner Wirkner advised that he has a conflict of interest on several levels. Commissioner Wirkner advised that he is a parishioner, and he is on Rotary, who supplies manpower to run Loaves and Fishes and Saint Vincent De Paul. Commissioner Wirkner advised that his wife and himself have both volunteered to supply both services, and he will abstain from any vote that the commissioners take. Commissioner Wirkner advised that he will still share his views. Commissioner Wirkner advised that he would use his own personal funds to support Saint Vincent De Paul, but he cannot vote to use taxpayer funds to support it. Father Jonas advised that he has two questions regarding the contract, one of which is the use of a freezer, and Saint Vincent De Paul does not use a freezer. Father Jonas advised that he doesn't think Worker's Compensation applies to Saint Vincent De Paul because they only use volunteers. Commissioner Modranski advised that is a legal question that needs to be run by the prosecutor. Father Jonas asked if a vote was going to be taken regarding lowering the price. Commissioner Modranski advised that the price was already lowered to \$500.00 Father Jonas asked if the commissioners would lower the rent even more. Commissioner Modranski advised that \$500.00 is the lowest they can go. Commissioner Leggett advised

that if they keep lowering the price, other people with leases are going to come and ask for theirs to be lowered as well. Commissioner Wirkner advised that the building was purchased for government use and the faster that the building can be used for the intended purpose, the better off the taxpayers of the county will be. Commissioner Wirkner advised that his takeaway was that the commissioners would continue to house Loaves and Fishes and Saint Vincent De Paul temporarily until they were able to renovate the building and use it for the purpose the government bought it for. Father Jonas said that is wonderful to know and that clears up some confusion he had. Father Jonas asked about the November rent. He advised that he only had three days to review the contract and is asking if the commissioners still want him to pay November's rent. Commissioner Modranski advised that he thinks that is fair considering that other renters have paid. Commissioner Wirkner advised that the contracts are to protect the commissioners for the period they are allowing other people to use and occupy the building. Father Jonas thanked the commissioners for their time.

Ms. Offenberger advised that she did an internal review of all JFS position descriptions and went through a point factoring process, scoring each position according to education, complexity, experience, supervision, and work environment. Ms. Offenberger advised that they have been using the same plan since 1995 and it needed to be brought into compliance with some different things. Ms. Offenberger advised that during scoring they aligned positions into new pay grades and looked at different pay scales that they could utilize. Ms. Offenberger advised that they have been working on the nuances of the plan since September. Ms. Offenberger advised that the plan was presented to the commissioners previously. Commissioner Wirkner asked if they were voting on the same plan that they were presented with earlier. Ms. Offenberger advised that it is. Ms. Offenberger advised that it is an attempt to retain and recruit staff. Ms. Offenberger advised that there has been a lot of turn over in the child welfare area and they are trying to retain and recruit staff the best they can. 
