#### **AUTHORIZING CARROLL COUNTY TO JOIN THE CUE COG**



Brian Wise, Carroll County Engineer appeared before the Board to ask for a resolution to join the Regional Council of Governments that is centered in Summit County. Mr. Wise explained that the Regional Council of Governments is a salt cooperative, and Carroll County was invited by Stark County to join. The Regional Council of Governments would need to amend their bylaws to allow Carroll County to join this cooperative. Mr. Wise advised that he already talked to the Prosecutor, and the Resolution is contingent on whether the Council is able to amend their bylaws and allow Carroll County into the group. Mr. Wise advised that if he cannot join the group, he will need to either put out a bid to purchase salt or get the salt from the Ohio Department of Transportation (ODOT). Mr. Wise explained that ODOT has more constraints regarding salt purchases than this cooperative does. Mr. Wise would like to join this group not just for salt, but they also bid out fuel, vehicles, and other items. Mr. Wise advised that there is a \$250.00 year administration fee which the Engineer's office will pay. Mr. Wise advised that the county must take at least 80% of the salt if purchased and must attend two meetings per year. Mr. Wise advised that he would attend those meetings. Mr. Wise advised that they will vote to amend the bylaws at their meeting on February 14<sup>th</sup>. Mr. Wise advised that it is his understanding that if they allow Carroll County into the cooperative, any Carroll County entity can join this group and take advantage of the salt, fuel, and vehicle bids. Commissioner Wirkner asked Mr. Wise how much money he would save per ton if he was in the Council of Governments cooperative. Mr. Wise advised that their prices are \$11 cheaper per ton. Commissioner Wirkner asked Mr. Wise if once he was appointed to the Board, could any Carroll County entity join the cooperative. Mr. Wise advised that is his understanding based on
