Tom Cottis, Emergency Management Agency (EMA) Director appeared before the Board to discuss a weather-related event that occurred on Friday, February 16, 2024. Also present were Joel Decker and Mandy Henderson of Regional EMS, and Tim Reichel of the American Red Cross. Mr. Cottis advised that 88 children on 4 busses from Pickerington, Ohio were going to the FFA camp on the evening of February 16th. The snowfall increased as they approached Carroll County and they were diverted to Azalea Road due to the bridge that is out in Bowerston. This area of the county had a small two-mile band of snow that came through and dumped over ten inches of snow. The first two busses made it up the hill. A car after the first two busses began to spin and then the last two busses could not make it up the hill. There were no injuries. The Carroll County Sheriff's office, Ohio State Highway Patrol, the Leesville fire department, the Sherrodsville fire department, the Carroll County Engineer's office and Regional EMS were all called. Leesville United Methodist Church opened their doors as soon as the fire department called them. Regional EMS used three ambulances to transport all of the children to the Leesville United Methodist Church. There were not enough blankets and the American Red Cross (ARC) could not get blankets to the site due to weather conditions. Regional EMS brought blankets and Ms. Henderson advised that the Carroll County jail, the Carroll Golden Age Retreat and Camp Wakonda all provided blankets as well. Regional EMS went to Carrollton to pick up the blankets as well as more pizza to go along with the pizza that the FFA camp sent over. The church also made spaghetti. Mr. Cottis advised that he and Mr. Reichel have a plan for the blanket issue. Mr. Reichel brought two cases of ARC blankets with him. Once case will go to Regional EMS to replace their blankets and the second case will be stored at the EMA office. Mr. Reichel advised that he is the ARC local representative and covers Stark, Tuscarawas, Carroll and Harrison counties. These counties have areas that are "off the main drag", and it makes sense to pre-stage items for events such as this. Mr. Reichel noted that the events of February 16th show what a small community can do. Mr. Reichel advised that if the events had extended to several days, the ARC would have taken over the feeding process.
