Currently, residents can reach dispatch by dialing 911 or 330.627.2141 and choose option 0. Ms. Jacobs advised that the Frontier technician is on-site in Marion now, and the problem should be fixed today. Ms. Jacobs advised that the she will need to test the system, and then she will send out an update on the WENS system. Ms. Jacobs advised that caller information is not populating through the CAD software because the calls are not coming in on the regular 911 line. The dispatchers are getting information from the RapidSOS software, which is the location software that dispatch uses. Ms. Jacobs advised that this is a state outage for anyone with Frontier. Commissioner Modranski asked if other counties are having issues with 911, and Ms. Jacobs advised that is correct. Commissioner Wirkner advised that he has several concerns including why the system didn't rollover and why the redundant Horizon service did not work. Ms. Jacobs advised that she has a list of questions for Frontier and for ComTech. The ComTech equipment is up and running so there are no answers right now. Ms. Jacobs advised that her primary focus over the last 24 hours has been to ensure that calls can get through. Commissioner Wirkner advised that he is sure that the Public Utilities Commission of Ohio (PUCO) will get involved.
