# **WORKERS COMPENSATION PREMIUMS**



Commissioner Wirkner advised that the Auditor's staff presented information to the Board regarding the 2025 Bureau of Workers Compensation (BWC) premiums. There is a shortage of approximately \$28,558.47 for the FY2025 period of January 1, 2025 through January 1, 2026. Commissioner Wirkner advised that the Board needs to discuss how to rectify the situation. Should the shortage be taken from unappropriated or split among the entities. Commissioner Wirkner advised that over 59% of the premium is for nongeneral fund departments, so he recommends splitting the shortage amongst the entities. Commissioner Modranski advised that the county has received rebates from BWC that have allowed the premiums to be paid, and departments have not had to budget for it. Those rebates are now used up, and there will be a shortage for the FY2025 payment. Commissioner Modranski recommends that departments budget for the FY25 shortage and the FY26 premium on their 2025 budgets. Commissioner Leggett advised that he agrees that the general fund should not be raided.
