9:15 AM

Commissioner Wirkner advised that the Emergency Management Agency (EMA) is required to do tier II reporting each year. All hazardous materials stockpiled by local companies must be reported so that emergency responders know what is on site and who is the contact person for the company. There are just over 3,600 companies that must report and three of them are historically late or don't complete the reporting at all. Commissioner Wirkner spoke to Tom Cottis, EMA Director and Mr. Cottis will be imposing a fine penalty of \$5,000.00 for each late reporting/nonreporting company. Commissioner Wirkner advised that it is important that EMA has the latest information. The intention is not to impede economic development, but companies need to understand that the tier II reporting is not optional. There is a safety related component to this. Commissioner Leggett asked if there is a cost to the company to report. Commissioner Wirkner advised that he believes there is an application and a fee. Commissioner Modranski asked if EMA has made more than one request. Commissioner Wirkner advised that repeated letters have been sent over the course of time. Commissioner Modranski asked if there is a fine to the county or EMA. Commissioner Wirkner advised there is no fine, but EMA needs to show they gave their best effort to collect the information. Commissioner Wirkner advised that three out of 3,600+ is a very good compliance rate. Commissioner Modranski asked what industry the three businesses are in. Commissioner Wirkner advised that all three are smaller oil and gas related companies.
