There were a total of 1331 criminal and civil cases filed in the Carroll County Municipal Court under Judge Gary L. Willen during 2024. These included 517 civil complaints and small claims actions, and 814 criminal and traffic cases.

Of the 814 criminal and traffic actions, there were 69 felonies, 312 misdemeanors, 58 driving while intoxicated charges, and 375 other traffic citations.

A breakdown of the filings of the 814 cases included: 270 by the Sheriff's Department, 57 by the Ohio State Highway Patrol, 67 by the Dog Warden, 10 by the O.D.N.R., 17 by the Lake Patrol, 294 by the Carrollton Police Department, 79 by other police agencies, and 20 by individuals.

Receipts in the Carroll County Court during 2024 total \$507,264.06, \$473,102.22 was paid to the following agencies: \$177,825.76 to the County for fines, \$3,221.00 to the State for fines, \$6,431.40 to the Sheriff's Department for sheriff fees and drug fines, \$3,765.00 to the Ohio Department of Natural Resources for Game Warden and Division of Forestry fines, \$300.00 to the State of Ohio for expungement of files, \$288.00 to the State of Ohio for seatbelts, \$352.50 to the State for liquor fines, \$22,564.95 to the State for Rotary fees, \$11,218.00 to the State for Legal Aid Societies Fund, \$224.00 to the State Board of Pharmacy for drug fines, and \$246,911.61 was paid out for garnishment payments, trusteeship creditors, various villages for ordinance fines, and deposit refunds. The Court has received \$98,951.94 through our website payments and Capital Recovery Systems has collected \$7,701.64 on delinquent monies due the court.

A total of 136 new individuals were placed on probation in 2024. A total of 1,450 hours of community service were performed. A total of \$36,154.42 was collected as a contribution in lieu of community service pursuant to O.R.C. 2929.27. A total of \$21,457.00 was collected in probation fees, and \$11,462.92 in restitution was collected and paid directly to victims.

The Court's balance on hand as of December 31, 2024, is \$103,251.34.
