Ms. Pavlik thanked the Board for hosting her and those in attendance with her for the proclamation for Overdose Awareness Day. Ms. Pavlik advised she is so grateful to have such wonderful partners including everyone in the room who continue to engage in efforts to reduce overdoses and support recovery. Through Project Deaths Avoided With Naloxone (DAWN) program at the Carroll County General Health District (CCGHD), overdose prevention efforts have expanded in Carroll County. Ms. Pavlik advised in 2024, the CCGHD distributed 268 Narcan kits, and in just the first half of 2025, they have already handed out 276 kits. Ms. Pavlik also shared that CCGHD is holding their first Overdose Awareness Day event on August 28th from 5 to 8 p.m. at the Carrollton Eagles. The guest speaker will be Kyle Overmyer, who has a powerful story to tell about addiction, recovery, and hope. Ms. Pavlik advised anyone in the community is welcome to join. The other organizations in attendance gave a brief description of what their organizations do and thanked the Board for their support.


