Ms. Trbovich advised that Transit also lost their contract with Council on Aging. Ms. Trbovich advised that Transit still receives funds from the Council on Aging for transportation, but it is at the public rate, which is much lower than the contracted price. Ms. Trbovich advised that the amount she needs to make up for the

loss of revenue is \$115,000.00. Ms. Trbovich advised that she wouldn't need all the money right now but would need half of it. Ms. Trbovich advised that she is not giving raises to her drivers, except for those employees who are in their probationary period. Ms. Trbovich advised that she would consider reducing her hours to help reduce operating costs. Ms. Trbovich advised that several letters written by Transit customers asking Transit not to decrease their hours of operation. Commissioner Wirkner advised

that it was already established that cutting the hours would not solve the budget problem and would be counterproductive. Commissioner Wirkner advised that he is not in favor of cutting the hours. Ms. Myers apologized that she could not continue her contract with Transit. Ms. Myers advised that she runs a meal business, not a transportation business. Ms. Myers advised that COA wants Transit to keep the hours the same so that the seniors in the county can make it to their appointments. Ms. Myers advised that there are ways to generate revenue, such as, grants, fundraisers, advertising on the vehicles, insurance contracts, and Triple A funds. Ms. Myers thanked Transit and its staff for all they do and offered to help in anyway she can. Commissioner Wirkner thanked Ms. Myers for reaching out and offering to help.
