Mr. Hale requested the floor to speak further on the subject. Mr. Hale displayed a presentation board with various media headlines. Mr. Hale read a letter to the editor that he composed. Residents can get help by calling 988, the Suicide and Crisis Lifeline; 988lifeline.org; or https://speakingofsuicide.com/resources/. Ms. Morris discussed the Suicide Fatality Review board that was recently formed. Suicides in Carroll County are double what the state's rate is. The data shows that 85% are men over the age of 50, and 95% of those are done by gunshot wound. Ms. Morris discussed the Suicide Prevention Coalition that is being led by the ADAMHS Board which provides strategies to reduce stigma. Ms. Morris advised that normalizing the conversation is the first step and discussed QPR (Question, Persuade, Refer) Training. Another strategy that is being reviewed is gun safety measures, as a way to delay that impulse decision. Another area of focus is the elderly population who have been newly diagnosed with life-changing diagnoses.

Kelly Morris, Carroll County Health Commissioner, provided an update on the monthly pop-up food pantries. Ms. Morris advised that the attendance is increasing each month. Over 100 families are served each time with 39 additional new families last month. Partners from local churches, the Mason's and other organizations have been volunteering at the pantries. There is an average of 15 volunteers at each pantry. The food pantries are held on the first Wednesday of each month at the Church of Christ. The program is free through the Akron Food Bank. The purpose is not to compete with the local food pantries, but to fill in the gaps. Akron Food Bank brings enough food for 150 families, and any extras are then given to the local food pantries. Commissioner Wirkner asked what type of food items are available. Ms. Morris advised that it varies each time but there's always canned vegetables, canned beans, fresh vegetables such as onions and potatoes. Sometimes there are pharmaceutical items. Commissioner Leggett advised that when he volunteered, they had catfish and Halls cough drops.

Kelly Morris, Carroll County Health Commissioner, advised that the Beacon Charitable Pharmacy will be coming to the Health Department on the 1st and 3rd Wednesdays. The mobile clinic is open to everyone. Ms. Morris advised that meds are available at a very reduced rate if the resident has no insurance or is in the "donut hole" with Medicare. Ms. Morris advised that Beacon Charitable Pharmacy will also accept donations of unused medications. Only charitable pharmacies can do this. The medications cannot be expired, and no narcotics are allowed. Ms. Morris advised that more information can be found on the Health Department website.
